- 2.2: The second element of this funding stream the Active Travel Neighbourhood Grants aims to support local projects which:
  - Support and strengthen local economies (encouraging people to walk or cycle to neighbourhood shops and services, rather than driving to other locations); and/or

 Increase physical activity to improve health, through greater use of walking and cycling for local journeys.

The first round of this fund has been assessed in October/November. The second round has a deadline of end of March 2013. The Traffic and Transport sub Group did not agree on any schemes to follow up.

#### 3. Update on Transport and Traffic Actions

- 3.1. <u>Section 106 Minor Traffic developments</u>:
  - a. (Knole Lane, junction with St Joseph's Road -£10,000 refuge island) and T5 (Brentry Lane, Charlton Lane, Swanmoor Crescent – £20,000 miniroundabout): Awaiting results of feasibility studies: see 1.2b above – additional funding now available from Local Sustainable Transport Fund. This could either upgrade this scheme or release funding to be used elsewhere – potentially to boost the funding available to the Swanmoor/Brentry Lane/Charlton junction project.
  - b. Aldi crossing on Crow Lane High Friction Surface installation: underspend of £582.37 from the s106 Funding which delivered this crossing. The bid to LSTF to install High Friction Surfacing did not succeed.

The BCC Senior Road Safety Officer advised in December 2012 that such a surfacing is 'highly recommended.'

He estimates a cost of £4,000 to install 30 metres of High Friction surfacing:

Half width of Crow Lane is 4.6m x 30m (length of HFS) x 2 (both approaches) = 276 sq.m at a cost of around £13 per sq m = £3,588 if Traffic Management is required = £100 Officer time = £250

#### **Potential Sources of funding:**

Underspend from Aldi S106: £582.37 Station Road S106\*: £3,417.63

£4,000.00

\*£11,310.12 available for The provision and/or improvement and/or maintenance of the following: a) supporting the orbital bus route which passes through the local area b) pedestrian and cycle provisions in the local area c) bus stop infrastructure upgrade.

If the Committee chose to approve this scheme it would be delivered in 2013/14 as the completion of the Aldi scheme.

The impact of this upgrade will be to improve the safety of the crossing, which will have positive impacts on all people using the crossing.

If approved, there would be £7,892.49 remaining in the Station Road s106 contribution

Recommendation: that the Neighbourhood Committee decide whether to approve the allocation of £3,417.63 from the Station Road S106 monies to install high friction surface work to this crossing

#### c. Pen Park/Charlton Road crossing improvements:

Pen Park/Charlton Road crossing improvements: This scheme has been a Minor Traffic Schemes priority since 2010. The developer, Taylor Wimpey, agreed in August 2011 to allow their S106 funding to be used to deliver this scheme. Highways have provided the following estimates. Potential Section 106 monies from the Wayfarer development may be able to be applied to this work to cover the indicated deficit.

Delivery of the scheme: this won't be delivered until 2014/15 because of the catch-up in backlogged schemes by Highways in 2013/14. The s106 allocation

has no time limit in the agreement so that doesn't put the funding at any hazard.

Recommendation: that the Neighbourhood Committee approve the allocation of the @£43,662.61 available from the Pen Park s106 to this scheme and that a decision to fund any shortfall is brought to a future NP meeting when more clarity about the Wayfarer s106 becomes available.

d. **Doncaster Road crossing and Lidl Southmead Road S106:** The bid to LSTF did not succeed. This scheme remains as a potential piece of work which could be funded by future Local Traffic Schemes budget. £10,000 remains available to fund this scheme from the Lidl s106 contribution, agreed at the 28<sup>th</sup>
March 2012 Horfield and Lockleaze NP meeting.

This scheme cannot be delivered until 2014/15 now.

e. £12,994.99 S106 for Henbury/Brentry Community Transport:

The delivery agreement between Henbury and Brentry Community Council and Lawrence Weston Community Transport has been drawn up and accepted by the Planning Obligations Manager and the first instalment of funding has been released.

# 3.2 Micro-asphalting of Wigton Crescent/Embleton Road, Southmead and update on BCC concrete road stabilisation programme:

The poor state of road surfaces in Southmead around Wigton Crescent and Embleton Road has been an ongoing concern of the Partnership.

#### Wigton Crescent/Embleton Road progress:

Highways still plan to get this work done in the early part of 2013. **Verbal update will be provided at the NP meeting** 

#### 3.3 **Southmead Road / Pen Park Road junction update:**

The mooted 'no left turn' proposals made by BCC Transport service to deliver junction improvements to support the new Southmead Hospital development were shared at a Southmead Neighbourhood Forum last year. At the Southmead Forum on 21<sup>st</sup> February the following statement was released:

Following on from the draft designs presented last year we received strong objections over the introduction of prohibited movements. As a result of these comments we have looked into alternative designs that overcome these concerns, however with the aspirations to improve traffic flow through this junction and the requirement to improve pedestrian accessibility this is proving very difficult.

The options are to be discussed with our service director as each option will involve an element of compromise.

Following the outcome of these meetings an informal consultation will be carried out, providing an opportunity for the local community to comment. The junction is of strategic importance to Bristol and the local Hospital, therefore any proposals will also need to take into account transport routes through the network

### 4.3. <u>Delivery of New Play Areas in Southmead and Henbury/Brentry: update</u>

- 4.3.1. Doncaster Rd: immediate residents surrounding the park have been consulted on the 3 siting options for the new play area and also a tree planting plan for later this year, deadline for responses is 8th March 2013. Friends of Group continues to be developed and will be on a recruitment drive on 16th March at the next Southmead market.
- 4.3.2. Pen Park: Issues have arisen about the preferred location for the play area a 3m buffer is required between houses and any new play area, also there is a 300mm sewage/drain pipe running through the site that requires 24 hour access, so no permanent structures can be placed above the site currently exploring other options with colleagues and Southmead Community Sports. Landscape Architect has been appointed.
- **4.3.3.**Okebourne: Engaging the Friends of Group to ascertain parameters and scope of the new play area, Landscape Architect has been appointed to help scope initial ideas and develop plans.
- **4.3.4.**Crow Lane: Initial discussions have taken place with Friends of Group, Initial designs for the new play equipment are in and are being assessed and a plan of engagement is being drawn up.

### 4.4. <u>Progress on installation of the totem pole and 2 new</u> waste bins on Barnard Park

4.4.1. Work will commence on site on **Wednesday 6<sup>th</sup> March 2013**, subject to weather conditions, on installing the bases required for the Totem pole and the bins.

The bases will need time to cure and so the likely finish date for the works will be either the 12<sup>th</sup> or 13<sup>th</sup> March 2013.

- 4.5. Progress on May Gurney Waste Plan development
  - 4.5.1. The May Gurney Waste Plan has been developed and is Item 7 on the Agenda
- 5. Henbury and Brentry Parks Improvement Prioritisation

- 5.1. The Neighbourhood Partnership requested at the 26<sup>th</sup> June 2012 meeting that the Area Environment Officer set up a Parks Investment Prioritisation Group for Henbury/Brentry to produce a Parks Investment Plan to bring back to the NP meeting.
- 5.2. It is the intention of the AEO to turn and focus on the update/refresh or development of the PIP for Henbury/Brentry following the development of the Waste Plan, timescales have yet to be determined but due to the number of Capital Stimulus Projects there is a need to utilise and capture the interest in this programme to develop this plan. To commence in April 2013.

#### 7. Neighbourhood Forum update

- 7.1. The Neighbourhood Forums took place on 13<sup>th</sup> February November in Henbury/Brentry and 21<sup>st</sup> February in Southmead.
- 7.2. 14 people attended the Southmead Forum and 16 people plus two Councillors attended the Henbury/Brentry Forum.
- 7.3. Henbury/Brentry ASB Survey: The Henbury/Brentry Forum heard the results of the Anti Social behaviour survey conducted at the Henbury & Brentry Fun Day and by the PCSOs.
- 7.4. Henbury/Brentry ASB Survey and the 2012 Quality of Life Survey compared:
  - 7.4.1. The Henbury/Brentry ASB Survey surveyed 135 people compared to the 107 respondents in the 2012 QoL questionnaire
  - 7.4.2. % residents satisfied with the neighbourhood as a place to live:

The Henbury/Brentry ASB Survey: 83%

2012 QoL questionnaire: 76% (city average: 82.5%)

Overall QoL trend: year on year improvement

7.4.3.% residents who think the neighbourhood has got better in the last 2 years

The Henbury/Brentry ASB Survey: 63%

2012 QoL questionnaire: 21.3% (city average: 18.3%)

### 9. Mayoral Visit, Friday 11th January 2013

- 9.1. As agreed in previous NP meetings, Councillors invited the new Mayor, George Ferguson, to visit a number of sites in our NP area to hear about current issues of concern and to explore what support he could offer
- 9.2. The visit itinerary included: Henbury Football Club; Blaise Estate; Brentry Lodge Youth Centre, the BS10 Planning and Parks Group and Southmead Adventure Playground.
- 9.3. Issues which the Mayor took away included the support needed to help communities develop Community Asset Transfer plans to take on youth premises and the need to

- bring South Gloucestershire to meet with communities in North Bristol to enable people to explore the impact of the large developments north of the city boundary and any mitigating measures.
- 9.4. The Mayor took away a commitment to support these issues, including writing to the leader of South Gloucestershire Council pressing for a North Bristol meeting.
- 9.5. Following the success of this visit the Mayor has committed to visiting the 13 other Neighbourhood Partnership areas in the city.

### 10. South Gloucestershire North Bristol Consultation event on their development plans

- 10.1. The Exhibition on Thursday 13<sup>th</sup> December 2012 at the Café, Greenway Centre, Doncaster Road, Southmead took place. It was not very widely advertised, however, so attendance was not great. But local people did comment on the proposals and these have been taken away by South Gloucestershire.
- 10.2. Since the Mayoral visit South Gloucestershire have contacted the Area Co-ordinator with a commitment to a further North Bristol event. The date for this is being negotiated.

### 13. Bristol Switch and Save scheme launching 21st February 2013

Bristol Switch and Save is a collective buying scheme aiming to move at least 5000 residents (and businesses on domestic tariffs) to better energy deals, helping them save money on their gas and electricity bills. Through collective bargaining with the Energy Companies we are likely to get a better tariff than through existing switching sites, and we take the hassle factor out of finding a better deal.

We are particularly keen to reach households who haven't switched energy supplier for some time (if at all), don't commonly use comparison websites and/or are confused about their options for buying energy. But any household could benefit – and the more people who join in, the greater our buying power on behalf of everyone. In similar schemes UK householders have saved up to £400 on their annual energy bills. Typical savings range from £125-£200 depending on circumstances and payment method.

How the scheme works, 1) register your interest through the website or use the freephone number provided, 2) Bristol Switch & Save will negotiate a tariff for the scheme for both fuel types and all payment types, 3) Bristol Switch & Save will contact you in April with the new tariff, 4) If this is better than what you are currently paying, you can agree to switch providers.
