### **Summary:**

# Safer Bristol Community Safety Officer Delivery Agreement outcomes for 2011/12

The CSO Delivery Agreement for 2011/12 reflected the community safety priorities set out in the Neighbourhood Partnership's strategic plan. These included action to:

- Raise the profile of Domestic Abuse in Kingsweston and Avonmouth Neighbourhood Partnership area
- Reduce crime, anti-social behaviour and the fear of crime.

There have been significant successes over the course of the year, with overall levels of crime and anti-social behaviour falling across the Neighbourhood Partnership area.

# **Key Outcomes**

Total crime in the Neighbourhood Partnership area fell by 7% or 257 offences from 2010/11. There were significant reductions in acquisitive crimes such as

burglary which fell by 28% or 88 less incidents in the past 12 months; criminal damage fell by 20% and robbery by 24% and there were 15% fewer violent crimes on 2010/11. Anti-social behaviour has also fallen by 5% across the area within the past year.

This reduction in crime and anti-social behaviour was backed up by increasing community confidence and reduced fear of crime in Avonmouth & Kingsweston. Notable headlines from the annual Quality of Life survey include:

- The percentage of people who say personal safety is a problem has fallen year-on-year from 41.5% in 2009 to 24.5% in 2011.
- Perceptions of anti-social behaviour being a local problem have fallen from over 47% in 2009 to 39% in 2011, (however the Lawrence Weston community Research suggests that 79.2% of residents feel that antisocial behaviour is a local problem). The percentage of people who think drunk and rowdy behaviour is a problem has also fallen in the Kingsweston area.
- Fear of crime has continued to fall across the Neighbourhood Partnership area and at 22% is below the citywide average.
- The public's confidence in the Police and Council dealing with the local issues that really matter has risen from 35% in 2010 to 41.5% in 2011.

Safer Bristol commissioned a new domestic abuse support service across North Bristol. The service, to be delivered by Next Link and called the 'Northern Arc', will provide support and protection to survivors of domestic violence and abuse.

These represent significant achievements for the Partnership; demonstrating agencies have successfully responded to the priorities raised by local residents. But there is clearly more to be done and in some areas further action is required. For example:

- Local concern that drug use and dealing is an issue has continued to rise across Avonmouth & Kingsweston. Indeed, drug offences rose by 13% in the last year – no doubt reflecting the proactive Police response to tackling North Bristol's drugs markets.
- Local perceptions that domestic violence and abuse is a private matter, and therefore less likely to be reported, remains high in the area. The Partnership anticipates a rise in domestic incidents over the summer of 2012.

#### The Year Ahead

The Community Safety Partnership's strategic aim is to reduce total crime by 15% by 2014 (i.e. no more than 43,310 recorded incidents from the 2010 baseline of 50,495). Our Strategic Assessment provides recommendations

for the Neighbourhood Delivery Teams across Bristol. The recommendations for the North Bristol NDT covering Avonmouth and Kingsweston are: tackle illicit drugs use and supply; reduce anti-social behaviour and its impact; address domestic violence and abuse. These themes complement the Avonmouth & Kingsweston Neighbourhood Partnership priorities and it is therefore proposed the Community Safety Officer's Delivery Agreement for 2012/13 sets out a programme of activity to continue to focus on these areas.

# Draft Delivery agreement

Safer Bristol
Community Safety Officer

- Safer Bristol will work with the Neighbourhood Partnership to develop its Action Plan around community safety priorities (crime/disorder, drugs and alcohol harm and anti social behaviour) and deliver a programme of work in 2012/2013 to address the community safety issues identified through the Action Plan.
- Safer Bristol will report back on this Agreement at a NP meeting once a year, the date to be agreed by the NP.
- The Community Safety Officer acts as a single point of contact to wider Safer Bristol services and support for the Neighbourhood Partnership. The CSO will work within the NP area to gather local priorities to help inform the production of the Neighbourhood Profile within Safer Bristol's annual Crime & Disorder Strategic Assessment.
- The CSO acts as the problem-solving advisor to the NP, using the ID PARTNERS problem-solving process. The CSO will provide briefings on the Problem Solving Process on request.
- The CSO will support the delivery of Neighbourhood Forums and the forum process, tackling crime and community safety issues raised when appropriate.
- The CSO will work with communities and partners to resolve community issues around Crime and Community Safety as identified through NP groups, other local groups and residents.

### Community Safety Priorities for the area:

The Safer Bristol Strategic Assessment provides recommendations for the Neighbourhood Delivery Teams across Bristol. The recommendations for the North Bristol NDT covering Avonmouth and Kingsweston areas from the assessment are: tackle illicit drugs use and supply; reduce anti-social behaviour and its impact; address domestic violence and abuse.

Total recorded crime in the Neighbourhood Policing Area (Southmead & Avonmouth) has reduced in recent years, in line with the citywide trend. A total of 50,495 crimes were recorded by the police in 2010/11, a decrease of 6.2% from the previous year. Moreover, in the year-to-date period from April to December 2011, there were 36,739 crime recorded, a further decrease of 5.1% compared to the same period in the previous year. From these figures it is estimated there will be around 49,000 crimes by the year-end. Our strategic aim is to reduce total crime by 15% by 2014 (i.e. no more than 43,310 recorded incidents from the 2010 baseline).

In 2010/11 there were nearly 61,000 incidents of anti-social behaviour reported to the city's authorities, down 12% on 2009/10 figures. Southmead and Avonmouth had nearly 8,000 reported incidents of ASB in the period (a rate of 101 incidents per 1,000 population). Kingsweston was well above the citywide average in terms of number of reported incidents of ASB, criminal damage and arson. Perceptions of ASB and fear of crime were also higher in this area.

The most common Neighbourhood Forum issues across the NP area are Traffic and ASB. Issues relating to drug dealing have also been raised.

Avonmouth and Kingsweston Neighbourhood Partnership's Action Plan highlights a number of actions around community safety and crime prevention and features many of the perennial problems in the area for residents. Priority themes that complement the NDT action plan include community cohesion, domestic abuse and ASB & drugs.

The CSO will support the area's NDT to act responsively to issues as they emerge by providing support around using the IDPARTNERS joint problem solving process and assisting in the development of problem solving plans.
