Recommendation:

That the Neighbourhood Partnership set up a Community Facilities sub-group to coordinate community buildings issues and to play an active part in the planning of community infrastructure in the Greater Brislington NP area.

1. Future of the Wicklea Centre and relocation of organisations & activities

- relocation support for existing Wicklea users is still available
- options for redevelopment of Wicklea to include 'community use'
- impact of the relocation on other venues and orgs

3. Future community infrastructure needs for the area

- need to define current 'needs' and future 'wants and needs' (next 20 years)
- identify opportunities for improving existing venues
- consider the future of underutilised or poorly maintained venues
- create a 'community hub' with co-located facilities
- identify the support needed to improve the capacity of vol orgs

4. Community Asset Transfer

The council's CAT Policy applies to all lettings of council-owned assets at less than full market value. This includes new ventures, renewals and Lease renegotiations. A Service Agreement will run alongside the Lease to enable rent-free use.

Minimum criteria for the organisations requesting CAT apply. A viable business plan or development plan is required and the local NP will be consulted on each CAT request. Full details and online resources can be found at: <u>www.bristol.gov.uk/cat</u>

5. Community Right to Bid (aka Assets of Community Value)

- although included in the Localism Act, local authorities are still awaiting details of exactly what the new Right will entail
- the Regulations, supposed to be laid in Parliament in April, have still not been published
- the council is therefore unable to consider nominations for listing at present
- once the new Right has come into force, community orgs that meet the criteria (set by Parliament) can nominate assets they believe to be of 'community value' to the council
- if both the nominator and the asset meet the relevant criteria, the council will add the asset to the List of Assets of Community Value

- once on this List, if an owner wishes to sell the asset, 'community interest groups' (criteria set by Parliament) can then indicate that they wish to bid to buy the asset
- this will delay a sale of the asset for 6 months, after which the owner is free to sell to anyone at whatever price they wish
- the council will be pro-active and will seek to make the nomination process as easy as possible for local communities to use.

6. Online tools & resources

- the council website contains various lists, maps and databases, eg Community Centre Finder, A-Z list of community venues for hire, interactive map of community venues, etc - visit: <u>www.bristol.gov.uk/communityvenues</u>
- various other statistics and data sources are available in map form and allows different datasets to be overlaid at once - visit: <u>www.bristol.gov.uk/pinpoint</u>
- other useful datasets in Pinpoint include all council-managed land, planning applications, listed buildings, etc
- BCC aerial photography and historic maps are available too
- <u>Historic Environment Record</u>: this also allows communities to submit information
- Know Your Place database: visit: <u>www.bristol.gov.uk/page/know-your-place</u> a list of all 'concessionary tenancies' is available; this shows CATs and all council assets used by vol orgs - visit: <u>www.bristol.gov.uk/page/concessionary-lettings</u>
- NPs will be notified of council assets to be disposed of; some details can also be found online - visit: <u>www.bristol.gov.uk/property</u>
- Community Asset Transfer: the policy and various supporting documents can be downloaded - visit: <u>www.bristol.gov.uk/cat</u>

7. Suggestions for community action

- local communities are encouraged to suggest further premises for our community venue database and the list at (2) above
- protect existing community facilities by opposing changes of use through the Planning system
- use the Planning system to generate financial contributions from developments, either to mitigate adverse effects (S.106 agreements) or to provide resources to provide infrastructure to match the growth (CIL)
- take part in council-led initiatives to establish the need for community infrastructure
- consider how the new Community Right to Bid might benefit your local community, eg by nominating assets that are of community value in your area
- work in partnership with the council to take over surplus assets (CAT)
- coordinate efforts between all community venues in the local area, eg by working closely together, sharing resources and expertise, avoiding duplication, referring booking enquiries, etc
