# **Bishopston Forum** Wednesday 5<sup>th</sup> September 2012

Date of Next Forum: 11<sup>th</sup> December, Memorial Stadium.

Representatives of Horfield Prison attended and discussed the work f the prison. They took questions and discussed the prison's role in the community. Residents were informed of an open day at the prison on Saturday 15<sup>th</sup> September. All residents were welcome to attend (prior notice required). Residents were also informed of the NP's working groups, including a new group launching in October to be called the BCR Street Scene Group. All are welcome to get involved. A first meeting of the group will be held on Wednesday 3<sup>rd</sup> October.

Issues raised at or prior to the Forum are listed below

No	Issue
1	Blocked drain at resident's home in Station Road. Resident thinks this is due to too many dwellings using same drainage system
2	Resident feels there is a need activities for young people, more community opportunities for meeting places, youth clubs etc. Suggests basketball net & possibly youth shelter behind Muller House in park, or new school.
3	Request from residents for basketball net for young people in Station Rd area.
4	Toilets closed in St Andrew's Park. What is happening about this? Are there restricted hours?
5	Station Rd. Teenagers from college smoking weed and hanging around on bench in front of green area in front of station. Suggested solution: talk to college.
6	Collection of bins and boxes in Lilstock Ave – half the time they are not collected.
7	Section 106 money from housing development: can we have more

	information about plans to put swings in park behind city of Bristol College (Brunel Site) and the plans to put in new café.
8	Litter and mess (bottles and glasses) outside late opening pubs such as Golden Lion (244 Gloucester Rd), also Lloyds TSB cash point, Sat am & Sun am
9	Play area in Horfield Common- needs updating, not enough things. A café would be good.
10	Path opposite park, speed bumps on path (5 in all), worse one at end of garages – need to paint bumps with yellow visibility paint. Garages behind Ardagh.
11	Rocks at bottom by garages, off Horfield Common, stop traffic – grass around it, poor visibility. Resident suggests clearing grass away.
12	Parking on the pavement – blocking pavement (private Rd owned by Persimmon). Taxi business. Resident suggests yellow lines or bollards.
13	Ashley Down Convenience Store (Mr Ali), Ashley Down Rd, Deliveries blocking road and pavement and cars parking on pavement. Resident suggests policing and painting some space on land so people will not overhand pavement.
14	Littering by students from the city of Bristol College on Arthur Milton St. Resident suggests more bins and educating of students.
15	Students kicking football against resident's wall by subcontractor car park Wed lunchtime. Causes of nuisance for resident at Arthur Milton St
16	Elton Road: Resident has requested the street be changed to one way.
17	Elton Road: Resident has requested trees to be planted in the street.
18	Elton Road: Cars parking on curb right by BT phone box prevents people passing with wheelchairs and pushchairs.
19	Cheltenham Road/Zetland Road Junction: the feeder cycle lane (between the 2 lanes of traffic) approaching this junction from the Arches has been reduced to 0.7m wide following resurfacing works – less than half the minimum width required.
20	Overhanging bushes on Salthrop Road coupled with cars parking on pavement makes it impossible to walk on the pavement.
21	Parking on Friary Road footpath. Resident suggests 'public footpath' notice needed at entrance to Friary Road to remind people it is a footpath and 'no parking' stickers put onto the posts in the meantime.
22	Grassed bank adjacent to Friary Road footpath urgently needs to be tidied with a mower/strimmer.
23	Large blue trade bin belonging to Ashley pharmacy keeps being put near corner and on pavement. (Seymour Road). A long standing issue.
24	Litter from City Of Bristol students in her road (Arthur Milton Street)
25	Access to Bishop Rd school playing fields needed for local residents because of no other green space in reach. Bishop Rd primary school.
26	Ground level leaf growth almost blocking pavement on Brookfield Ave
27	Cycling on the pavement - Gloucester Rd /Ashley Down
28	Parking on the pavements - Seymour Rd and other roads across the Ward

29	Cycling on the pavement - Gloucester Rd / Ashley Down Rd.
30	Burglaries - Bishopston Ward
31	Blight/ rubbish in front gardens etc 186 Ashley Down Rd
32	Maintenance of Muller Open Space especially dog poo and litter
33	Request to have a student programme in place, prior to their return
34	Speedwatch enquiry / confusion re the new process
35	Lack of maintenance, ASB, new notice' Dirac residents only'. Open Space
	between houses on Dirac and Lilstock Roads.
36	Mini cabs illegally waiting/parked on yellow lines outside their HQs at
	Arches/Stokes Croft causing cyclists to pull out into traffic. This presents a
	danger for cyclists and goes against Bristol's 'cycling city' status.
37	Request for information on setting up a Neighbourhood Watch.

Date of Next Forum: 5<sup>th</sup> December, Cairns Road.

Stephen McNamara, Head of Legal Services for Bristol City Council attended to discuss the upcoming mayoral election in Bristol. The powers of the mayor, the election process and a description on the differences between now and how the council will be run were discussed. The meeting then broke in to topic tables at which residents were able to discuss specific issues relating to Parks, Highways, Policing, Street Scene. These were fed back to the meeting as issues for officers to take away and resolve.

Issues raised at or prior to the Forum are listed below

3	Black bins left out on pavement, on Raglan Rd, for 2 weeks. Resident

4	A boards continuing to be an obstruction for pedestrians on Gloucester Rd,
	particularly narrow section from Parade (The Prom, Tart) going towards
	Berkeley Rd. The Florist has A boards on both sides of the road.
5	Cars continuing to park on pavement all along Lindon Rd particularly between
	traffic lights and Cranbrook Rd.
6	Parking on both sides of Durdham Park from commuters and Torwood House
	school parents prevents emergency services from getting through to Carfax
	Court (elderley persons' residential accommodation). Plans to turn Clay pit
	Road into one way will push more traffic onto Durdham Park.
7	Turning into Durdham Park from Westbury Park by car is difficult because of
	parked cars on the corner.
8	Parking restrictions on dropped kerbs installed in Redland with Section 106
	money from Redland Green School: These dropped kerbs are in a 'special
	enforcement area' resulting in traffic wardens frequently issuing penalty
	notices for parking on them. What steps were taken to inform drivers that this
	is a special enforcement area? Also, can penalty notices be justified when
	given outside of school times as the purpose of the dropped kerbs was to
	achieve a 'Safe Route to School'?
9	Redland Green: grass has not been cut for 18 months on slope above
	retaining wall to Redland Road. This area was agreed to be left as hay-cut in
	Spring last year 2011. It has not been cut since then i.e. no cut last Autumn.
	There are daffodil bulbs in the area so the grass needs to be cut in early
	autumn before the daffodils starts to grow through. Please can you confirm
40	when this will be done?
10	Redland Green: The triangle of grass between paths and steps at Cossins
	road entrance has not been maintained since the steps were completed.
	An access point has been made by removing a section of the rail but the
	contractors have not maintained this area this year. A number of self set
	shrubs have colonised the space as well as weeds. People cannot clear up
	after their dogs because of the undergrowth so it is becoming very
	unpleasant here.
11	Redland Green: Cycle/pedestrian signs have been defaced. Pedestrian
	symbol has been pained over – can this be cleaned off please?
12	Redland Green: Potholes on access road to farm and allotments. Is this
	access road going to be renovated? At one stage, we understood that
	money had been found to resurface this road, and that the Farm residents
	were going to make a contribution towards this.
13	Redland Green: Poor maintenance work on tree branch – larger pieces were
	removed but smaller bits left in place – residents eventually cleared it up
	themselves.
14	Redland Green: grass not mowed until it is very long, then cuttings left on top
	of grass and on path. Looks very unsightly – is this what the contract allows?
	Has been ongoing issue this year.
15	Redland Green: The path across the grass triangle in front of the church,
	from the Woodstock Road to the church gates, has been allowed to get

	narrower and narrower and is in a very poor condition. Is there any money to						
	deal with this? Under the contract shouldn't the grass be kept back from						
	encroaching onto the tarmac area. Can this be looked at?

# **Cotham Forum** Tuesday 11<sup>th</sup> September 2012

**Date of Next meeting:** Thursday 6<sup>th</sup> December 2012. Tyndale Baptist Church, Whiteladies Road

#### Issues discussed at the meeting:

- Licenced premises. Neil informed the meeting that a number of licence applications have recently been refused, as per the Cumulative Impact Area status of Whiteladies road
- Costa Coffee received its planning consent. Costs attached to the appeal by Costa do not apply to the Whiteladies Road branch

- There is a limit to the number of tables and chairs premises can have outside their premises. The amount of space taken up is the main factor regarding
- Police are looking at licencing issues on Cotham Hill. Also moving the street drinkers on
- Crime is significantly down on last year in the ward
- General concerns were expressed about Cotham Gardens. Cannabis smoking, poor lighting
- A Friends of Cotham Gardens Mailing list is being drawn up, to enable residents to be kept informed of developments
- In 6 months time it is hoped to have a police office on, or near, the Whiteladies Road
- Experimenting with communal bins on Chandos Road. Could it work elsewhere?
- **Discussion on Whiteladies Road**. Hamish described the plan for a retail officer. Idea is to have a more diverse shopping area.
- There is the issue that many of the properties are for the night economy
- Transport to the shops for people who live a distance away is difficult as there aren't many direct buses. Car parking is also expensive.
- Cyclists are concerned about road safety at the new pinch points on WL Road. The idea is to change the behaviour of cyclists and make them more assertive on the road, so that they feel comfortable not moving over to let vehicles squeeze by.
- Most people agree that the WL Road now looks really good.
- Steve Riley agreed to look at the issue of displacement due to the new parking restrictions
- A consultation on a possible parking permit scheme north of railway line will begin after December, with potential implementation by end of 2013
- There followed a discussion on the rights of students to have parking permits. It was pointed out that they are residents too
- Issue of improper cycling is partly an educational challenge. Promotion on safe cycling takes place in the schools
- As soon as Parking Services give the okay, all signs on WL Road are enforceable. Afternote: Now in place

# Issues raised at the forum for officers to take away and try to resolve are below

- Cars parking in designated cycle lanes. This is a problem on Cheltenham Road and Gloucester Road
  Can residents be encouraged to take their bins in once empty? This is a particular need with student houses. Where people are asked to, it tends to work
  Cotham Road. The pavement is in a poor state of repair. Can it be checked and repaired please
- 4 Student HMOs tend to respond well when directly approached about problems.

#### 2. Devolved budget updates

#### Clean and Green

The Neighbourhood Partnership has an allocation of £1,500 per annum under this budget. At the last NP meeting in June, the NP agreed to allocate £750 from this allocation for paint and sundries for 2 street and park projects. Additional requests were made for Community Payback sessions, which come from a separate fund. Remaining Clean and Green allocation for 2012/13 is £750.

#### <u>S106</u>

Section 106 allocations are now made by the NPs, working with officers from the relevant teams. As can be seen in the table below, there are 4 allocations that can be made by this NP. The 2 Parks allocations earmarked for improvements to parks and open spaces (£8,683.19 & £19,384.49), are subject to possible allocation to matchfund this NP's selected Parks Capital Stimulus Fund projects (please see relevant agenda item). Of the 4 Parks projects identified for funding in BCR, 3 require matchfunding. It is assumed that the bulk of this match-funding will be requested from these 2 S106 allocations.

If the Committee allocates the recommended amounts of S106 to the Parks Capital Stimulus projects, a residual **£3,260.19** remains from the 06/02256 Gloucester Rd development. The money needs to be spent by 31st January 2013. The Committee is asked to consider and <u>agree</u> green space improvements that might be made with this amount and allocate the money accordingly. All three parks identified to benefit from the Parks Capital Stimulus Fund lie within the required one mile of the 2 developments that generated the relevant S106 allocations.

The provision of **£4,599.36** is for tree replacement in the vicinity of the new office block development at the top of Redland Hill. The NP may wish to liaise with the BCC Tree Officer on this matter.

The allocation of **£64,125.04** had previously been allocated to provide improvements to community facilities within the (previous) Sefton Park Youth Centre. As this youth centre no longer exists, a deed of variation was agreed with the developers, Persimmon, to allow the money to be spent on improvements to community facilities in the vicinity. Consequently, at the extraordinary Neighbourhood Committee held on  $3^{rd}$  September 2012, the funding was re-allocated to support the rebuilding of the scout hut on the adjacent Williamson Road site.

#### Local Sustainable Highways Grants

You will recall that this NP, along with all other NPs, submitted applications for projects to this fund at the end of July. The NP submitted 8 applications. The successful projects have now been announced. We have been successful with 2 projects:

- Junction alterations to North Road and Cromwell Road (Redland)
- Crossing on Coldharbour Road ((straddling Redland and Henleaze wards)

There is also a possibility of a 3<sup>rd</sup> project, which is on the reserve list:

• A crossing point on Redland Green

Clarity is currently being sought regarding what being on the reserve list actually means.

#### 4. Well Being Update

The Area Coordinator wishes to correct the minutes and apologise for providing the last NP with the wrong total of Well Being funds carried over to the current year. In the Annual Business Report submitted to the NP in June, it was stated that the amount carried forward, plus the £30k budget for 2012/13, totalled £36,017.51. The actual total figure carried forward should have been £41, 463.51.

This occurred because the original amount awarded to 2 projects (£5,000 for Tree Planting 2008/9, £3,664 Glos Rd Task Group) was wrongly stated as the carried forward amounts, rather than the unspent amounts of £1,180 and £2,038 respectively from the original allocations. This means that the NP had a larger carried forward amount to the current year.

The NP is asked to note that under-spends may not be allowed to carry forward next year, making it important that all the Well Being funds are spent or allocated. The Well Being Panel has received some suggestions for projects, which are outlined in Jenny's report.

The NP is also requested to note that there are a number of allocations from the NP that have been carried forward in to the following year at least once. The NP is requested to note these allocations and, where appropriate, agree to either spend the money on the originally agreed purposes, or to discuss re-allocating the monies. The allocations (with notes) in question are as follows:



#### 5. 20 MPH consultation

As NP members will be aware, this NP has been at the forefront of efforts to provide residents with the opportunity to recommend and influence the possible introduction of 20mph roads in the NP area. As a result of its efforts, the NP has been included in the first area of the city to be consulted on this scheme. Please see the map below.

A series of consultation opportunities were provided to residents in this area during September. It is understood that a significant number of residents have attended the consultation sessions and/or submitted their views via the web page provided for consultation on this subject (there is still time to submit views. Go to: <u>https://www.surveymonkey.com/s/DJM5XXG</u>). Unfortunately, the NP wasn't able to promote the consultation sessions, and as a result was very concerned that residents weren't being provided with an adequate opportunity to comment. As a result of these concerns, the consultation has been extended to enable residents to attend the December Neighbourhood Forums and question Highways officers and submit their views. The dates and venues of the next forums are listed in the table below.

BCC Highways officers will attend the next NP meeting in January and will provide a report setting out the results of the consultation and how the decisions will be made regarding which roads will or won't have 20 MPH speed limits introduced.
