Title: RECOMMENDATIONS FOR THE ALLOCATION OF THE WELLBEING FUND

Since the original report was submitted, the Grants Subgroup has received additional information about some of the applications which has resulted in a change to some of the recommendations. The changes are highlighted below:

## **2.1** Sefton Park Scorpions Football Club

On reflection it was felt that recommending £4,080 to <u>be released</u> on a <u>year-by-year basis</u> for the underwriting of the playing fields lease for *three* years rather than five was a more proportionate allocation to a comparatively small user group. As the current lease runs until the end of 2013/4, this should still provide the club with sufficient security to be able to continue to attract other funds as well as develop a sustainable funding stream for the future.

- 2.2 Redland and Cotham Amenities Society Cotham Gardens
- 2.2.1 The Grants Subgroup was informed that the play equipment and other items in the application were provided through local

fundraising so in fact the Council has no responsibility for maintenance. In view of that, and the high number of local children using the equipment, it was felt appropriate to recommend funding the play equipment in its entirety, but not the repairs.

- 2.2.2 Likewise the railings were provided through public fundraising and so their maintenance is not a Council responsibility. ARCAS feel there is scope to work with the Council to see how it could be funded in other ways.
- 2.2.3 However the Grants Subgroup feels that the dog bins remain a Council responsibility.

### 2.3 Redland Green School

Further information has been suggested to the Grants Subgroup that:

- Perhaps a website is not necessarily the best or only medium for facilitating consultation with young people
- That the PTA and the school could be approached to offer some funding, as the work envisaged would be done in curriculum time, not as an out of school project
- That there may be peer volunteers eg university students, who might be able to provide assistance to reduce the costs.

The Subgroup recommends that Partnership should demonstrate its support for work which engages young people within their communities by recommending a grant of £450 where the school can demonstrate it can find any additional resources.

#### 2.4 BCR NP – Street Trees

The Grants Subgroup has been informed that the Council need to know by 31<sup>st</sup> March 2013 the number of trees and their sites, in order to plan the construction of the tree pits. (Applications for further trees received in 13/14 would not be planted until 14/15.) The up-to-date information is that the sites of six trees are confirmed and with the underspend of the tree budget and additional charitable and private money, the overall shortfall is £4,630.64. In order to ensure that the trees get planted in 2013/4 it is recommended that the additional £130.64 should be added to the original proposal, bringing it to £4,630.64.
