I am currently seeking confirmation as to whether this camera has already been installed, and if so, what the costs were. If it has been installed, the contribution will be used to cover the relevant costs, however if it has not been installed then the contribution will be devolved to the Neighbourhood Partnership.

## **NOTE**

The Partnership are requested to take a decision on whether they wish to spend the contribution highlighted in blue, on local parks improvements, or whether they wish it to be applied to the King Street Bridge. If the former, then the contribution will be devolved as per the devolution criteria, however if the latter then it will move into the non-devolved spreadsheet. It should be noted that if King Street Bridge is to be implemented it is likely to require every available Section 106 contribution to be applied to it, as no other funding has currently been identified for it's delivery.
