- Series of guided walks throughout the year.
- Commemorative tree planting
- Fun Run. (tbc)
- Victorian themed picnic.

The following events will be held <u>in addition</u> to those listed above if HLF funding is secured. (total budget £50,000)

OPTION 2

- History Trail with information boards and trail leaflet.
- Oral History Project.
- Cricket Match.

Please note: The Cricket match has been included in option 2, however if the contingency (£2500) included in option 1 is not used it will be possible to go ahead with the cricket.
