4. Based on current expenditure trends there is likely to be a deficit on the account of £39,657. This will be met from reserves at the end of the financial year. All the expenditure has been previously approved and to date includes improvements to the Downs depot, clearance work at Bridge Valley and some preliminary work in connection with the 150 th anniversary celebrations.

£45,000 has been charged to the reserve for work completing the railings at the sea walls. The balance on the reserve, excluding the commitments above is £214,682.
