Restricted access / road closures on the Downs

I would be grateful if I could have raised at the next Downs Committee the following item.

"Is the Downs Committee consulted and made aware of and by so doing gives agreement to the number of times the road access to and around the Downs is restricted or totally closed off due to the number of events, primarily sponsored walks/races, being held on the area, denying access for many groups of people and vehicular traffic."

As operator of the <u>"City Sightseeing" Bristol</u> open top guided bus service, this greatly reduces "Wow" factor of the Tour as the contrast between the City and the open area of the Downs is immense and as such is one of the jewels in the crown. The Downs is greatly appreciated by visitors and locals alike when they take the Tour and we are all disappointed whenever we are unable to take the bus up Fountains Hill, around Circular Road, Downleaze, Rockleaze, Stoke Road and Ladies Mile.

It does seem that is easier for the authorities to close the roads rather than manage the events in safe manner and let the events take place on the grassed area.

Also many of these events are a great showcase of the City's charitable and caring nature and as such we would love to be able to show these off to our passengers.

It also severely reduces the access to the Downs, which I thought was the whole point of the Downs Act, in letting the citizens of Bristol free and uninhibited use of the 441 acres. By closing Circular Road in particular the vehicle access to the viewing point, and ice cream van, means that many groups of people, from families, elderly and to those with mobility problems are denied access.
