## 9. New Events Proposed for 2014

The first meeting of the Downs Committee Events Sub – group met to discuss the possibility of The Kite festival relocating to The Downs in 2015. All agreed this was a possibility and supported the move subject to the usual licences and permission process.

The Foodies Festival which has been based on the Amphitheatre in previous years has also expressed a desire to relocate to The Downs bringing with it its 3 day showcase of food and drink. This is a proven, commercial ticketed event that has previously been held within the Harbourside region. The ambition is that the Foodies Festival will become a regular feature on The Downs.

Funderworld have confirmed that they would like to return in 2015 at the original dates in April and officers are exploring options.

Members of the committee expressed a desire to have more understanding about the Film office and its remit on the Downs, in particular the associated fees and charges for filming activity. The appendix to this report offers more detail about the Film office.

# <u>Bristol Film Office</u> <u>A Division of Bristol City Council's Arts, Events & Film Team</u>

The Bristol Film Office was introduced by Bristol City Council in January 2003 as part of the city's media strategy. The Film Office joins a global network of 300 national, regional and city film commissions, all operating in a fiercely competitive arena to attract inward investment to their jurisdictions from regional, national and international companies.

Bristol Film Office has now embedded its brand and increased the exposure of Bristol within the production industry. This has resulted in the city's established reputation as a viable, cost-effective and trusted location to base media businesses and create film and TV projects.

Strategic Objectives of Bristol Film Office:

- To increase filming activity and develop Bristol's film and TV industry by providing a co-ordinated effective service delivery and business support
- Ensure that moving image culture and the creative industries become a distinctive brand for the city
- Increase levels of inward investment to the city through production activity
- Optimise the potential growth of the city's production companies
- Maximise the development potential of the city's media industries

The Film Office works to achieve these objectives through an integrated set of actions. These include:

- Providing a one-stop-shop service to the production industry
- Promoting the city's creative industries on an international level, increasing its profile as a prolific regional production centre

- Maintaining a comprehensive on-line library of filming locations and a competitive local crew and facilities guide
- Delivering industry development projects, as well as providing advocacy and representation for the city's media sector
- Acting as a conduit for development initiatives, funding intelligence and advice
- Acquiring film and TV product for cultural and tourism based promotional campaigns for the city

The Film Office's achievements, particularly in creation of job opportunities and overall sector support and development, provide valuable models which are applicable across other creative sub-sectors.

Specifically the Film Office delivers:

- Inward investment opportunities for the city through attracting production and businesses to Bristol
- Job opportunities for local personnel working in the creative industries, a key priority sector for the city and region
- Devising and partaking in sub-regional and regional sector development initiatives with other local authorities and regional agencies

Bristol Film Office continues to make a valuable contribution to Bristol City Council corporate objectives on various levels. Demand for the services offered by Bristol Film Office has grown rapidly since it opened. #### **Downs Filming Income Levels Analysis**

The decrease in filming income levels to The Downs included in the table above demonstrates a number of factors that have contributed to changing industry trends and fluctuating levels of filming income across the city as a whole. These are as follows:

- In September 2011 BBC Casualty left Bristol, moving the entire production to Cardiff. BBC Casualty's regular activity around The Downs contributed to an average of 41 percent of total Downs filming income between 2007/08 and 2011/12. The loss of such a long-standing TV production that relied on the use of Bristol locations and unit parking for 48 episodes per year hit overall filming income across the city hard. It has resulted in an average annual loss of £4359.81 to The Downs.
- 2. To mitigate the loss of BBC Casualty for Bristol, Bristol City Council looked to The Bottle Yard Studios in Hengrove to attract increasing levels of high-end productions to Bristol and make efforts to fill the production gap that BBC Casualty's departure left. This shift in focus to attracting studio-based productions was also in response to changing industry trends. In April 2007 the UK Government announced competitive tax relief incentives for feature films working in the UK. In April 2013, this was enhanced by additional tax relief measures for big-budget TV drama series. As a result of these incentives, Bristol (as well as other UK cities) has seen much larger, studio-based productions working in the city, replacing the lower-budget, location-based TV series such as *Teachers, Skins, Being Human* and *Mistresses*. Location-based productions regularly used The Downs for unit parking and locations, contributing an average of £4298.00 per annum of income to The Downs. The change in the types of productions that we are seeing working in the city and the shift to studio-based productions has resulted in additional loss of filming income for The Downs on top of the loss of BBC Casualty
- 3. Since Casualty's departure in 2011, and with the shift in production trends to studio-based filming, we have seen an increase in the percentage of income to The Downs coming from small TV productions. These are primarily documentaries, factual, reality and test shoots, all of which have

notoriously low budgets and have seen their budgets cut even further in recent years. These types of productions contribute an average of £670.00 per annum in income to The Downs.
