Context

- **4.** At present the council has a budget of around £3million (net) to support bus services. The budget aims to fill gaps in the commercial bus network, by providing services that it considers to be socially necessary.
- 5. The budget covers around 47 contracts that provide 'standalone' services, Park and Ride services and 'add-ons' to the commercial bus network in the morning, evening and at weekends. The contracts came into force in September 2011and are under contract until September 2016.
- **6.** The council has 3 park and ride sites in Bristol, located in North West Bristol (A4 Portway), South West Bristol (A370 Long Ashton) and South East Bristol (A4 Bath Road).
- **7.** All 3 park and ride sites have a dedicated service direct to central Bristol and there are opportunities for connections to the Downs.
- **8.** In April 2014 we expanded the park and ride offer by re-routing supported service 505 to start/finish at Long Ashton Park and Ride.
- **9.** Service 505 operates Monday to Saturday between Long Ashton Park and Ride and Southmead Hospital and Sundays between Bower Ashton and Southmead Hospital. The service operates on a half hourly basis to Southmead with increased frequency to Clifton during the peak periods.
- **10.** In September 2014 the offer was further increased by the introduction of service 901 from Portway Park and Ride to Clifton.
- **11.** Service 901 operates a limited stop Monday to Saturday service between Portway Park and Ride and Clifton, on a 20 minute frequency from roughly 0700 1900.
- **12.** Both services 505 and 901 serve the downs and can be accessed from the stops at Blackboy Hill.
- 13. The Downs can also be accessed by a number of commercial bus services: 1, 2, 8, 9, 16, 40, 40A and 41, with each operating between 10/20 minutes Monday to Saturday and 20/30 minutes on Sundays, with a combined frequency from the Centre to the Downs of every 2 minutes. Several of these services operate late night journeys on Monday to Saturdays.
- **14.** The above commercial services provide a direct link to the Downs from the following areas: Broomhill, Brislington, Stockwood, Knowle, Temple Meads, City Centre, Clifton, Redland, Whiteladies Road, Stoke Bishop, Sea Mills, Shirehampton, Avonmouth, Lawrence Weston, Henbury,

Cribbs Causeway, Westbury-on-Trym, Brentry, Henleaze and Southmead.
