#### **RECOMMENDATIONS**

(1) That Dundry View Neighbourhood Committee agrees the priorities for 2012/2013 (and notes the proposed actions within the delivery agreement Appendix 1)

### **Summary:**

- Community Safety Officers (CSOs) work on a Neighbourhood basis. Dundry View's named CSO is Emily Smith. She works part-time and covers 2 Neighbourhood Partnership areas. Her programme of work is informed by four main sources:
  - Priorities identified by Neighbourhoods through Neighbourhood Forums and Partnerships - formally agreed by Neighbourhood Committees as part of their devolved services.
  - Priorities identified through Safer Bristol's strategic assessment
  - The Quality of Life survey
  - The Neighbourhood Delivery team action plan priorities (in part informed by the above)
- 2. The Neighbourhood Committee has devolved influence on work of CSOs and can influence priorities for the officers to work on this is the neighbourhood element of the CSOs work programme.

### Community Safety Priorities for Dundry View NP 2012/2013

- 3. The process for choosing the neighbourhood priorities for 2012/2013 in Dundry View has been:
  - a. Emily Smith CSO for Dundry View attends all neighbourhood forums (unless on annual or sick leave). Attending the forums helps her identify emerging issues at a community level across all three wards as well as engaging with a variety of community members and representatives.
  - b. Various meetings between the CSO, Neighbourhood Coordinator and other interested parties such as the Chair of the Neighbourhood Delivery Team to collate priorities and suggest actions to deliver these priorities for the year.
  - c. Draft priorities and delivery agreement sent to the Neigbourhood Co-ordinator for distribution and comment.
  - d. Finalised neighbourhood delivery agreement presented to Neighbourhood Committee for agreement.
- 4. The neighbourhood Community Safety priorities identified through this process for 2012/13 are:
  - a. Tackle Hate Crime
  - b. Reduce the fear of crime and increase community confidence
  - c. Tackle ASB
  - d. Tackle drugs

These priorities form part of the CSO's work plan, the CSO for Dundry View has been guided by the draft document and has worked on the priorities contained within it in anticipation of the Neighbourhood Committee agreeing them formally at a full Neighbourhood Partnership. The rest of the CSO work plan is set by the Community Confidence Manager and covers other Neighbourhood Partnership areas and various themed cross border work such as facilitating partnership working and problem solving training.

5. The CSO will undertake to feedback progress on the agreed actions and invite new issues from the Neighbourhoods from December onwards.

# Draft Delivery agreement

Safer Bristol Community Safety Officer Dundry View Neighbourhood Partnership

- Safer Bristol will work with the Neighbourhood Partnership to develop its Action Plan around community safety priorities (crime/disorder, drugs and alcohol harm and anti social behaviour) and deliver a programme of work in 2012/2013 to address the community safety issues identified through the Action Plan.
- Safer Bristol will report back on this Agreement at a NP meeting once a year, the date to be agreed by the NP.
- The Community Safety Officer acts as a single point of contact to wider Safer Bristol services and support for the Neighbourhood Partnership. The CSO will work within the NP area to gather local priorities to help inform the production of the Neighbourhood Profile within Safer Bristol's annual Crime & Disorder Strategic Assessment.
- The CSO acts as the problem-solving advisor to the NP, using the ID PARTNERS problem-solving process. The CSO will provide briefings on the Problem Solving Process on request.
- The CSO will support the delivery of Neighbourhood Forums and the forum process, tackling crime and community safety issues raised when appropriate.
- The CSO will work with communities and partners to resolve community issues around Crime and Community Safety - as identified through NP groups, other local groups and residents.

## Community Safety Priorities for the area:

The Safer Bristol Strategic Assessment provides recommendations for the Neighbourhood Delivery Teams across Bristol. The recommendations for the Bishopsworth NDT covering Greater Bedminster and Dundry View areas from the assessment are: tackle hate crime in the Dundry View; reduce anti-social behaviour and its impact particularly along East Street and Bedminster Parade focus on environmental issues of graffiti and fly-tip; tackle serious acquisitive crime within the Southville ward with a focus on a reduction in dwelling burglaries; ASB caused by young people in the parks within Greater Bedminster.

Total recorded crime in the Bishopsworth Neighbourhood Policing Area (NPA) has reduced in recent years, in line with the citywide trend. A total of 50,495 crimes were recorded by the police in 2010/11, a decrease of 6.2% from the previous year. Moreover, in the year-to-date period from April to December 2011, there were 36,739 crime recorded, a further decrease of 5.1% compared to the same period in the previous year. From these figures it is estimated there will be around 49,000 crimes by the yearend. Our strategic aim is to reduce total crime by 15% by 2014 (i.e. no more than 43,310 recorded incidents from the 2010 baseline).

In 2010/11 there were nearly 61,000 incidents of anti-social behaviour reported to the city's authorities, down 12% on 2009/10 figures. Bishopsworth NPA had just over 9,000 reported incidents of ASB in the period (a rate of 152 incidents per 1,000 population). Hartcliffe and Whitchurch Park are above the Bishopsworth neighbourhood Policing area average in terms of number of reported incidents of ASB, criminal damage and experience 1.5 times the citywide number of deliberate fires/arson. Perceptions of ASB and fear of crime were also higher in all three Dundry View wards.

The most common Neighbourhood Forum community safety related issues across Dundry View NP area are motorcycle nuisance, speeding, parking, dog fouling and ASB. Issues relating to street drinking, and drug use have also been raised.

The Community Safety Officer will concentrate actions around community safety and crime prevention and the work will feature many of the perennial problems in the area raised by residents. Priority themes that complement the NDT action plan including ASB, building community capacity & tackling hate crime.

The CSO will support the area's NDT to act responsively to issues as they emerge by providing support around using the ID PARTNERS joint problem solving process and assisting in the development of problem solving plans.
