1. Back Ground

1.1 At the Neighbourhood Partnership meeting on the 9th December 2013 the Neighbourhood Partnership agreed 8 key local priorities for the Neighbourhood Working team to work on, these are detailed below.

1. Parking

A parking audit was carried out which identified 43 streets across the Neighbourhood Partnership which were over the threshold for obstructive or dangerous parking. I will be discussing this and organising some education and enforcement activities with Parking Services and the Police.

There are also some roads that were not identified during the parking audit that have been raised as problems during

Neighbourhood Forums. We will be posting diaries through to residents on these streets for them to fill out to record the extent and timing of the problems they are experiencing. These will then be incorporated into our education and enforcement activities.

Problematic parking around schools was also not captured by this audit. These will be dealt with by working with the schools, residents, Parking Services, Police and City Transport (to promote Active Travel options). We will be starting this with Cheddar Grove Primary School, Bishopsworth and Bridge Valley Learning Campus, Hartcliffe.

2. Dog fouling

The following have been identified as dog fouling hotspots. We will be working with Heather and the PCSOs to carry out regular (possibly monthly – depending on resources) street patrols and door knocking exercises to speak to dog owners and residents about dog fouling to work through this list.

Bishport Ave

Cobhorn Drive

Illchester Crescent

Maynard Road

Miltons Close

Queens Road lane to Redford Crescent

Queens Road

Sherrin Way

Outside Headley Park School

We will also be working with the PCSO based at Bridge Learning Campus to tackle dog fouling focussing on Millenium Green. A concentrated campaign of awareness raising; education and then enforcement is being tried out in a North Bristol Park which is heavily fouled. We will look to transfer the most effective elements of this programme to try out in a Dundry View park.

We will hold a Dog Show this spring/ summer on one of the larger, problematic parks eg Wilmott Park, Kings Head Lane Park, or Withywood Park.

3. ASB

We are working with the police to identify what the ASB is and how to work together to tackle this issue. There is a strong hotspot for this activity around Morrisons. We will also be discussing ASB, in form of motorcycle nuisance, at the skip day at Macey's Close on the 13th March (see point 3. below).

4. Drug dealing and use

We will be working with the police to identify what the problem is and how to work together to tackle this issue.

5. Litter

The following hotspots were identified following a Neighbourhood Partnership audit by the Waste Officer, Anne Newman: Teyfant Rd – associated with pupils from Bridge Learning Campus – work with Julia Pett PCSO for school to resolve Hareclive Rd

Whitchurch Lane & Lakeside Drive

Fulford Road

Cutler Road – probably school related?

Queen's Road

We will be taking a similar approach to dog fouling, point 2. Above, and also carrying out litterpicks with schools. Again, we will be starting with the Bridge Learning Campus.

We will be carrying out a campaign to tackle the number of "escaped" Morrisons trolleys. Ideas include having a competition for residents for the most number of trolleys reported, reviving the Trolleys-in-streams survey that Living Rivers used to carry out and building on Carol Donovan's work with Morrisons to tackle the problem.

6. Flytipping

We are holding a Skip Day at Macey's Road which was identified as the top spot for flytipping, on Thursday 13th March.

Largely organised by Sophie Burns from Knightstone Housing. This will be used as an opportunity to tackle some of the other issues in this area eg ASB (motorbikes), and parking that have been identified through Forums and audits.

7. Recycling

Housing are purchasing the installing the mini-recycling centres. Prior to installation we will carry out an information day which will involve door knocking with flyers to promote when and how to recycle. Locations:

Faber Grove

Four Acres & Borleyton Walk

We will also be promoting recycling at the skip day at Macey's Road through the Waste Doctors from Kier.

8. Domestic Abuse

We are mapping out the process of how organisations pick up on cases of Domestic Violence and how this could be improved. The police have already assigned a PCSO to work on Domestic Abuse cases and offer support to those who are not deemed to be high risk by the Police Protection Unit, these non-high risk cases do not currently receive any support from the police. We are putting together a support pack for police officers who attend incidents to pass to victims if Domestic Abuse is suspected when they are called to an incident.

And finally, we are encouraging residents to fill in residents diaries if they feel that their street is a hotspot for one of the above issues, but is not listed above. If residents are keen to do this, can they please contact me on caroline.hollies@bristol.gov.uk or 0117 92 23977.
