## RECOMMENDATIONS

- That the Neighbourhood Committee approves the recommendations from the Dundry View Funding panel for the allocation of Wellbeing Funding.
- 2. That the Neighbourhood Partnership approves the recommendations from the Dundry View Funding panel for the allocation of Green Capital Funding.
- 3. The Neighbourhood Partnership makes a decision on the balance of the Green Capital funding as this needs to be allocated by the end of March 2015 and cannot be carried over for a further grants panel. This will be based on a recommendation from the Neighbourhood Partnership Manager (Heather Williams)
- 1. The Dundry View Neighbourhood Partnership has £5456.02 available funding in the Wellbeing Budget which includes one returned grant and one asked to be reconsidered for another project.
- 2. The Dundry View Neighbourhood Partnership has a Funding Panel that meets to discuss funding applications received and to make recommendations to the Neighbourhood Committee for allocating the funding. The panel is made up of local residents and councillors.
- 3. The panel met on 16<sup>th</sup> February and made the recommendations contained in the table below:

## **Legal Information**

When councillors decide how the wellbeing fund is spent they should have due regard to the public sector equality duty that applies to all public bodies. This duty is contained in the Equality Act 2010 and came in to force on 6 April 2011. It replaces previous equality duties under the Sex Discrimination, Race Relations and Disability Discrimination Acts.

The duty means that councillors are required to have due regard to the need to:

- Eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited under the Act
- Promote equality of opportunity between different groups
- Foster good relations between people from different groups

The duty covers the following protected characteristics:

• Disability, Sexual orientation, Age, Gender reassignment, Religion and belief; Sex, Race, Pregnancy and maternity.

It also applies to marriage and civil partnership, but only in respect of the requirement to eliminate discrimination and harassment.
