Recommendations

This report is from the Area Co-ordinator. It is for information and decision and Neighbourhood Committee members are recommended to:

1. Agree to release £3,000 from the Knowle Wellbeing Grant Fund to support the Redcatch Park Community Sports Court Improvement Project.

Context

A need has arisen for the Neighbourhood Committee to make a provision from the Knowle Well Being grants budget of £3,000 to enable the Redcatch Park Community Sports Court Improvement Project to proceed.

Towards the end of last year the Knowle East Youth and Communities Project, supported by Quadron and Bristol City Council, submitted a bid to the SITA Trust for the improvement of the Tennis Courts at Redcatch Park.

This bid, which was valued at £55,000 (which includes a Contributing Third Party payment of 11%), was successful and will lead to a vastly improved sporting offer for the area.

Unfortunately between the submission of the bid and now the actual cost of the project has risen by £3,000 due to an increase in material costs. This means that the project will not happen unless additional funds are found.
