Title: Neighbourhood Working Priority Setting

RECOMMENDATION:

That the Filwood, Knowle and Windmill Hill NP choose up to 10 Neighbourhood working priorities from the list in Table 2.

What is Neighbourhood Working?

Neighbourhood Working is a new way of working adopted by the council at the end of March 2013. It coordinates different council services and external organisations (eg the police) to tackle community priorities set by the Neighbourhood Partnership.

Current Situation

- 1. A list of priorities for each ward was gathered by:
 - a. Door to door surveys across the three wards
 - b. Online survey publicised via local networks and on the Neighbourhood Partnership web pages
 - c. Historic ward forum data was scrutinised
- 2. The list of priorities by ward is shown in Table 1 (data sets are available if required).
- 3. Other data sources, e.g. police reports, Quality of Life surveys, were used to provide additional evidence to support these priorities. This enabled the ward lists to be combined into a shortlist of 16 combined Neighbourhood Partnership priorities, ranked according to the number of times the issue was raised by residents, see Table 2.

Next steps

- 1. The Neighbourhood Partnership to choose up to 10 of the priorities from Table 2 below at the meeting in January.
- 2. Once the priorities are chosen a baseline against which progress will be measured, will be set. This may involve further data collection, to define the issue, for example identifying fly tipping hotspots or finding out how issues are currently being dealt with.
- 3. An action plan will be put in place working with all stakeholders, and implemented.
- 4. Quarterly progress reports will be provided for the Neighbourhood Partnership with updates given at the Partnership's request. Reports will also be published on the website.
- 5. The priority list will be reviewed annually by the Neighbourhood Partnership.

Filwood, Knowle and Windmill Hill Neighbourhood Working Priorities

From the survey, 8% of residents in Filwood, 42% of residents in Knowle and 20% of residents in Windmill Hill had no issues. That is 22% of all residents surveyed across the Neighbourhood Partnership area had no issues.

1	Dog control and dog	Raised as an issue by 25% of all residents surveyed.
	fouling	In Filwood ward residents were also concerned with keeping dogs under control.
		There were 29 reports of dog fouling to Bristol City Council Customer Services
		between July and December 2012 and 58 reports in 2013 to end September 2013
		(May Gurney). There was 1 report to Bristol Parks from October 2011 to September
		2013 (Parks Enquiries, 2013).
		Since April 2013 the Dog Wardens have received 26 complaints about stray dogs
		and 5 complaints about dangerous dogs in Filwood ward.
		90% of respondents in Filwood, 80% in Knowle, 79% in Windmill Hill feel that dog
		fouling is a problem in the local area, this is far above the city average of 76% (QoL,
		2012) and these figures have increased since 2005.
2	Parking including schools	Raised as an issue by 22% of all residents surveyed.
		This includes parking outside schools which has been recognised as a city-wide
		issue (Talking Heads, 2013). This has been an issue in this NP since 2005 when
		70% of respondents from Filwood, 59% from Knowle and 60% from Windmill Hill had
		a problem with cars blocking the local pavement (QoL, 2005)
3	Litter	Raised as an issue by 10% of all residents surveyed.
		There were 250 requests for street cleansing to Bristol City Council Customer
		Services in 2012 (May Gurney).
		There was 1 report to Bristol Parks from October 2011 to September 2013 (Parks
		Enquiries, 2013). This is likely to be an error in recording these enquiries.
		Only 48% of respondents in Filwood are generally happy with the level of litter on
		streets and other public land, whereas 66% of respondents in Knowle and 63% of
		respondents in Windmill Hill are happy. Although, 83% of respondents in Filwood,
		80% in Knowle and 73% in Windmill Hill say that street litter is a problem (QoL, 2012)

4	Drugs and alcohol issues	Raised as an issue by 9.3% of residents surveyed.	
		The number of clients accessing structured treatment for alcohol and drug use is 364	
		across all wards (170 in Filwood, 69 in Knowle and 125 in Windmill Hill) from 1 st April	
		2013 to 30 th September 2013. Of these 10% are alcohol users, 12% are non-opiate	
		drug users and 79% are opiate drug users (Safer Bristol data, 2013).	
		It is estimated that, citywide, in 2011/12 only around 72.5% of opiate or crack users	
		are on structured treatment, so the actual figures will be higher than this. In addition	
		around 16% of those drug users and 7% of alcohol users in structured treatment	
		citywide were referred through the criminal justice system. (Safer Bristol, Crime and Disorder, 2013)	
		80% of respondents in Filwood, 43% in Knowle and 45% in Windmill Hill said that	
		drug dealing is a problem in their neighbourhood but only 64% of respondents from	
		Filwood, 19% from Knowle and 24% from Windmill Hill said that drug use was a	
		problem in their area. In both cases the response in Filwood was well above the	
		Bristol average, average in Windmill Hill and and below average in Knowle(QoL,	
		2012). These figures have decreased, quite significantly in Windmill Hill ward only,	
		since 2006 (QoL)	
5	Speeding	Raised as an issue by 8.8% of residents surveyed.	
		There have been a number of road traffic accidents concentrated on the main roads	
		around the periphery of the NP area, such as Wells Road, Hengrove Way, Hartcliffe	
		Way and Airport Road though there is no evidence that this is linked to speeding

	All the issues below were raised by fewer than 8.5% of residents surveyed. However, some issues are ward specific, for example congestion was raised by 9% of respondents in Knowle, but not at all in Filwood and Windmill Hill.

7	Facilities for YP/children – includes gangs of YP	and local public services are successfully dealing with issues of crime and anti-social behaviour in their area. 21% of respondents from Filwood, 10% from Knowle and 12% from Windmill Hill feel that crime has got worse over the past 3 years (QoL, 2012). 25% of respondents in Filwood, 26% from Knowle and 21% in Windmill Hill were satisfied with leisure facilities/ services for teenagers, this is around the Bristol average and has increased from 17%, 4% and 10% in 2005. 59% of respondents in Filwood, 78% in Knowle and 82% in Windmill Hill were satisfied with children's playgrounds, the Bristol average was 67% (QoL, 2012).
8	Waste collections	Respondents in Filwood, Knowle and Windmill Hill are generally happy with the general- household, food and dry waste collections, with satisfaction rates around the Bristol average (QoL, 2012). However, the Council does not collect figures about littering and replacement of bins after emptying. These were the main issues for the residents surveyed.
9	ASB	ASB figures from Avon and Somerset are 489 for Filwood, 286 for Knowle and 393 for Windmill Hill for the first two quarters of 2013-14. This has increased compared to the same time period last year in Knowle and Windmilll Hill, but decreased in Filwood (Safer Bristol ward profiles, 2013). Knowle Estate Management Team, who cover 3 NP areas, have registered 190 action- planned ASB cases against tenants for the period 1 st April 2013 – 1 st November 2013 and recorded 16 Hate Crime cases in the same period. ASB takes up approx. 70% of Senior Housing Advisors time. There were 7 reports to Bristol Parks from October 2011 to September 2013 (Parks Enquiries, 2013). 37% of respondents in Filwood, 42% in Knowle and 42% in Windmill Hill feel police and local public services are successfully dealing with issues of crime and anti-social behaviour in their area (QoL, 2012). 52% of respondents in Filwood, 22% in Knowle and 26% of respondents in Windmill Hill feel that antisocial behaviour is a problem locally, this is higher than the Bristol average in Filwood but lower in Knowle and Windmill Hill (QoL, 2012) and has significantly declined since 2005 (QoL). Although police figures

		show that the numbers of ASB incidents has increased since 2012.
10	Fly-tipping	There were 331 reports of flytipping to Bristol City Council Customer Services in 2012
		and 559 reports in 2013 to end September 2013 (May Gurney).
11	Problem neighbours	53% of respondents in Filwood, 36% in Knowle and 32% in Windmill Hill said they have
		noise from neighbours, these figures have increased since 2005 (QoL). 46% of
		respondents from Filwood, 70% from Knowle and 74% from Windmill Hill said that
		people treat other people with respect in their neighbourhood, this has increased since 2006 (QoL)
12	Obstruction of pavements	Highways (2013) receive around 1300 enquiries a month city wide about Highways
	– bins or hedges	issues with includes potholes, enquiries about existing schemes and overgrown bushes.
13	Dangerous crossings	There have been a number of road traffic accidents since 2010, 23 of which involved
	0 0	pedestrians, around the Neighbourhood Partnership area (Pinpoint, 2013). Near misses
		are not recorded.
14	Motorbikes/ quads	There were 352 calls to Avon and Somerset police concerning nuisance bikes/quads in
	-	south Bristol in 2013 to date, reported mostly as Anti-Social Behaviour, with some
		incidents of riding without helmets.
15	Congestion	This includes issues raised with rat running because of congestion. It was only raised in
		Knowle as a significant issue. Of the road traffic accidents since 2010, many were a
		result of turning movement between minor to major roads and nose to tail collisions
		which are likely to happen in traffic jams.
16	Domestic violence	This was anly raised as an issue by and resident across all three words, however Ool
		This was only raised as an issue by one resident across all three wards, however QoL
		indicates that over 13% of respondents felt that domestic abuse was a private matter.
		This may be masking the severity of this issue in the area.
		There were 87 domestic abuse incidents in Filwood, 35 in Knowle and 31 in Windmill Hill for the first 6 months of 2013-14 (Safer Bristol, 2013)
