RECOMMENDATIONS

That the Neighbourhood Partnership notes and agrees the Neighbourhood Partnership Action plan.

That the Neighbourhood Committee agrees that the priority headings will subsequently be used as the criteria for Wellbeing funding.

- 1. The Greater Brislington Neighbourhood Partnership does not have an approved action plan.
- 2. The Neighbourhood Partnership has been using the Brislington Community Partnership (BCP) Action Plan to guide its work. This plan was developed in 2008 and does not contain some key aspects of the Neighbourhood Partnership's work. It is proposed that the Neighbourhood Partnership adopts an updated plan which has been developed using information acquired in the last 2 years as well as information collected during the development of the BCP action plan.
- 3. The purpose of a Neighbourhood Partnership Plan is to:
 - Provide information that Neighbourhood Committees can use to help inform the spend of devolved budgets including Wellbeing funding
 - Provide an overall picture of local need that could be used to consider future investment in the Neighbourhood Partnership area (for example to evidence the need for planning contributions, to form background information for external funding applications)

- Identify service improvements needed within the Neighbourhood Partnership area
- Identify partners that could be invited to work more closely with the Neighbourhood Partnership
- Document information about long-term aspirations for the Neighbourhood Partnership area.
- Provide a plan to help to target limited resources to and measure success against
- 4. The proposed Neighbourhood Partnership Plan (contained within appendix A) was developed by using the Brislington Community Partnership Action Plan of 2008 as a base and matching the priority areas within this plan to priorities that have been raised over the last 2 years in the following public arenas:
 - Neighbourhood Forums
 - Environment Groups
 - Transport Groups
 - Community outreach work
 - Brislington Web Forum
 - Wellbeing funding applications and monitoring
 - Other work of the Neighbourhood Partnership

Priorities from the BCP Action Plan that are still current have been retained, and some new priorities have been added.

- 5. Some action plan aims are already in progress and some are longer-term aspirations for the area. For each aim a lead person has been suggested. This might change over time and the intention is that statutory organisations, voluntary sector organisations and local people work together to deliver the aims.
- 6. The Greater Brislington Neighbourhood Partnership Plan will help deliver the work of the Neighbourhood Partnership, and will complement the Brislington Community Partnership Plan.
- 7. The proposed Neighbourhood Partnership Plan is a working plan and will be reviewed annually. Updates on achievements will be provided in the You Said We Did report at each Neighbourhood Partnership meeting.
