RECOMMENDATIONS

- The Greater Brislington Neighbourhood Committee is asked to make a decision on the alternative location of the BMX & mountain bike track for Arnos Court Park.
- 2. If the Committee agrees the alternative location, £15,537.91 additional funding will be required. The Committee is asked to make a decision on using the remaining £15,537.91 from the Birchwood Road Prefab site Section 106 allocation (08/01798). This has to be spent or committed by 10th September 2015 and fulfils the criteria set down under planning gain through the provision of improvements to Parks and Open Spaces within one mile of the Birchwood Road Prefab Site

Background

At a public meeting held at Arnos Manor Hotel on 4th February 2013, some residents voiced their concerns about the proposed location of the BMX pump track by Kings Road. As a result, an alternative location has been put forward for a BMX & mountain bike track near the Arnos Manor Hotel boundary wall – see map in appendices.

Context

The alternative location will require a tarmac path, in order to access the BMX & mountain bike track - this can be seen on the map. Temporary surfacing will be required during the construction phase to protect the ground from vehicles and machinery accessing the site. Some additional earthworks will be required on the alternative location. Architrail will require additional design

fees for the new location. The work is estimated to cost £60,537.91 in total.

Consultation

Public meetings held at Arnos Manor Hotel on 2nd September 2010 (over 100 attendees), 22nd September 2011 (18 attendees), 10th July 2012 (9 attendees) & 4th February 2013 (42 attendees).

Architrail public consultation event at Arnos Vale Cemetery on 20th September 2012.

Bristol City Council's Detached Youth Service team consulted with 45 young people in Arnos Court Park during May 2012.

Letters sent to properties surrounding Arnos Court Park on 17th May & 13th December 2012 and 20th February & 29th August 2013.

Updates given at Greater Brislington Neighbourhood Partnership meetings held on 19th March, 12th June & 15th October 2012 and 18th March 2013.
