Devolved Local Traffic Schemes for Decision

Background

- 1. In 2013-14 a backlog in delivering local traffic schemes was acknowledged and a pause in decision making was agreed by the Partnerships, in order to deliver the backlog of schemes.
- 2. Unallocated devolved budgets have been carried forward from 2013/14 meaning that from April 2014 your local traffic scheme budget is £31,271. This funding will be subject to the final accounts of the current schemes.
- What has become clear during the pause is that there is still not enough capacity within the Highways Delivery Team (specifically not enough personnel) to deliver more than 14 local traffic schemes per year, in addition to the S106, IBFF and LSTF schemes etc.
- 4. Prior to 2009/10, when budgets were devolved to the NP, traffic management officers delivered local traffic schemes but since the devolution of the budgets the number of staff in the team has decreased while the workload has increased.
- 5. The last three to four years have shown that realistically, the Highways Service can only deliver one scheme per Partnership per year.

- 6. At the Neighbourhood Partnership meeting in March 2014, it was proposed that:
 - Each Neighbourhood Partnership be limited to choosing one local traffic scheme per year, which we know is deliverable; and
 - Each Partnership considers choosing schemes for a 2 to 3 year programme, and we will endeavour to work flexibly to deliver these schemes as quickly as possible within this timescale.
- 7. At the Neighbourhood Partnership Traffic Sub-Group meeting dated 20th August 2014, the partnership members present, supported by highways officers, prioritised 62 requests and issues down to two priority schemes for 2014/15 and 2015/16.
- 8. The recommendations from the Traffic Sub-Group is as below:

Recommendation

Local traffic schemes

1. The Neighbourhood Committee as asked to approve the local traffic schemes recommended by the Neighbourhood Partnership Traffic Sub-Group meeting dated 20th August 2014.

Year	Location	Description of Scheme
2014/15	West of Wick Road - Exact area to be defined but to include streets either side of Sandy Park Road up to Wick Road	Parking Restrictions
2015/16	Wick Road/Newbridge Road	Feasibility and design of highways improvement to identify issues

- 2. The Traffic Sub-Group also recommends that £3,000 is put into a fund to be called Minor Works Fund to enable minor works such as dropped kerbs and bollards as examples to be delivered.
- 3. Any requests for funding from the Minor Works Fund to be emailed to

Ward Members for approval.

- 1. The Equalities Impact Relevance Check has been reviewed and determined that due to the fact that this decision has no impact on those with protected characteristics in the following ways a full equalities impact assessment is not required:
 - Access to or participation in a service;
 - Levels of representation in BCC workforce; or
 - Reducing quality of life (i.e. health, education, standard of living)
- 2. Generally, older people, those with a physical disability, or a mobility impairment are more likely to be disadvantaged than others with protected characteristics when there are footway maintenance issues.
