### Legal Information

When councillors decide how the wellbeing fund is spent they should have due regard to the public sector equality duty that applies to all public bodies. This duty is contained in the Equality Act 2010 and came into force on 6 April 2011. It replaces previous equality duties under the Sex Discrimination, Race Relations and Disability Discrimination Acts.

The duty means that councillors are required to have due regard to the need to:

- Eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited under the Act
- Promote equality of opportunity between different groups
- Foster good relations between people from different groups

The duty covers the following protected characteristics:

• Disability, Sexual orientation, Age, Gender reassignment, Religion and belief; Sex, Race, Pregnancy and maternity.

It also applies to marriage and civil partnership, but only in respect of the requirement to eliminate discrimination and harassment.

### Proposal for Yourbrislington.com

Much of the following information is also the case for yourstockwood.com should you wish for me to run their website too or any other area of Bristol.

The Brislington website could be so much more than it is now. It could be a real hub for the community that covers what is going on here, is a one stop shop for people's needs and enquiries from schools to hospitals, dentists to parks, history to future events, historic buildings to the types of trees.

#### **Set Up Costs**: £750

Domain Name and Hosting: to be renewed annually (£100) Theme Purchase, Web Design and Set Up: £200 Initial Page Content: £450 (30 hours)

Monthly Cost: £300 (20 hours per month)

#### Website Set Up

The set up will include buying a professional theme, developing front end content, site mapping, writing and developing a Welcome to Brislington video, adding important photos, working with Bristol Past and Present to go into the history of Brislington.

#### Monthly Activities:

I judge that the website will require 20 hours a month at £15 per hour which will include adding content to the site, discussions with groups, event listings, joining meetings in the area, social media activity and more. This will also include the monthly hosting fees and annual domain name fees.

#### Areas:

The website will be divided into multiple areas, pages and sub-pages. This level of content will make it the number 1 stop off point for people Googling information about Brislington.

#### Main Pages:

#### Home Page:

Brief intro about Brislington, photos, links to main pages and a welcome to Brislington video.

#### News:

original re-writing of any news stories that make local media about Brislington. This could also include notices and warnings such as road works etc... Any such notices given by the council or reported locally could be shared via social media (see below).

#### Listings:

Dedicated pages for listing groups in the Brislington area. Possible page for local businesses (strict to make sure they fall within the Greater Brislington boundaries) and then for facilities, charities and so on. Also a database of Facebook groups and important Twitter accounts.

#### Campaigns:

The website will cover and support local campaigns such as those to save Wick Road Library and Brislington Meadows.

#### About Brislington:

This will include pages on modern Brislington, the history of Briz (integrating where possible Know Your Place), local amenities, the blue plaques of Brislington (we have a few here and there).

#### Social Media:

In addition to adding content to the website, I will undertake social media interaction via Facebook (dedicated pages, administering the BCP page) and Twitter to promote events and facilities in Brislington via a dedicated Twitter account.
