#### Context:

The Greater Fishponds Neighbourhood Partnership (GFNP) is one of 14 Neighbourhood Partnerships introduced across Bristol. It was officially

launched in November 2008 and has been operating ever since. The Partnership covers three wards, Eastville, Frome Vale and Hillfields. It is

located in east Bristol and shares a boundary with three other Neighbourhood Partnerships, namely Lockleaze and Horfields NP to the north, St George NP to the south and Ashley, Easton and Lawrence Hill NP to the West. It also shares a boundary with South Gloucestershire to the east.

**Population:** The total population estimate in 2008 for the Greater Fishponds NP is 37,306. Of the three wards Eastville experienced the largest increase 13.1%, which is above city average of 8.0%. Hillfields had an increase of 8.3% and Frome Vale 6.7%, which is less than city average\*.

The age profiles of the three wards are very different. In Hillfields children make up more than a fifth of the total population 20.3%, this compares to citywide average of 16.7%. Whereas in Frome Vale pensioners make up more than a fifth of the total population 21.5%, this compares to city average of 15.2%. The population profile in Eastville is inline with city average\*.

Based on the 2001 Census, Eastville has the highest percentage of Black and Minority Ethnic (BME) residents 17.6%, this is twice as high as Frome Vale and Hillfields, with estimated BME residents of 8% each. This compares to city average of 8.2%\*.

**Housing:** In 2009 there is an estimated dwellings of 15,983 of which 76% are houses and 23.4% flats. This is above city average of 67.3% houses

and and 32.7 flats. Between the periods of 2001 and 2009, the area saw high levels of residential development, of which 90.8% were flats\*.

**Multiple deprivation:** Super Output Areas are a national geography for reporting statistics at different levels. In total there are 22 Lower Level of Super Output Areas in the Greater Fishponds Neighbourhood Partnership. These are made up from groups of Census Output Areas and have an average of 1,500 residents<sup>\*</sup>.

Gill Avenue is the only Lower Level SOA that falls into the most deprived 10% nationally for Multiple Deprivation. Multiple deprivation takes into account income, employment, health and disability, education, skills and training, barriers to housing, crime and living environment deprivations. Followed by Greenbank, Hillfields North and Hillfields East who fall in the most deprived 11-20%\*.

**Education, skills and Training** is a particular issue for GFNP. Gill Avenue, Hillfields East, Hillfields North and Lodge Hill all fall in the most deprived 10% nationally, whereas Greenbank falls in the 11-20% most deprived for this domain\*.

Crime: Crime has remained below city average, however youth offending is higher than average in Hillfields and Frome Vale\*.

**Education:** Educational achievement for both KS2 & 4 is around city average, with the exception of Eastville. Eastville has shown a slight drop in KS2 and the biggest improvement in KS4\*.

**Health and Wellbeing:** Generally the health and wellbeing indicators for Eastville and Frome Vale are inline with city average. Elderly people admitted to hospital for falls is high in Frome Vale, as is social care needs for residents aged 65 years. Poor liveability and higher fear of crime may contribute to the low feeling of happiness in Hillfields, when compared to city average. It also has significantly worse obesity rate than the city average\*.

#### Sustainable community indicators:

Most of the sustainability indicators for Eastville and Frome Vale are about average for the city. However, Hillfields, is worst than the city average for many of the social cohesion indicators, with low levels of trust and respect in the Neighbourhood\*.

Hillfields also has a lower feeling of safety and satisfaction with the neighbourhood. 45% of Hillfields residents feel the neighbourhood has got worse in the last two years\*.

Eastville residents have more of a problem with traffic pollution and are less satisfied with the appearance of the streets and open spaces but they are more likely to have reduced their household waste to tackle climate change\*.

#### ii- The NP Action Plan

The NP Action Plan is a local strategic document, which provides a framework to bring to together local community issues and aspirations. These are referred to local community priorities. The Action Plan is divided into two sections. Section 1 focus on NP priorities. These are aspirations identified by the local community, which may or may not relate to services that are delivered by Bristol City Council (BCC) or police. Section 2 of the NP Action Plan deals with local priorities that relate to devolved BCC budgets and services. Devolved council budgets & services are Highways, Street Scene, Bring banks, Parks, Community Safety, Clean & Green and Section 106. Section 106 is part of planning legislation. It can require developers to pay monies to the Council to provide measures to mitigate the impact of their development. Section 1 has one subsection under the heading of the Greater Fishponds Planning Work Plan and Section 2 has three main subsections, namely Community Safety, Traffic & Transport and Environment and Street Scene. With the exception of Community Safety, these headings reflect the names of existing subgroups in the Greater Fishponds NP.

#### Section 1:

- Greater Fishponds Planning subgroup; this section covers the work plan of the Planning subgroup, which is mainly concerned with the development of a strategic Local Neighbourhood Development Plan to guide planning decisions and to inform strategic developments for the area, local community provision and the impact of large developments in the NP area.

#### Section 2:

- Community Safety; in March 2011, the Greater Fishponds NP Board approved a Community Safety work plan for the Neighbourhood Partnership area. Safer Bristol is the lead agency delivering this work plan in close collaboration with the police. This work plan contains local community priorities raised at various engagement activities.

Traffic and Transport; this section mainly deals with issues relating to traffic and transport, including devolved work plan priorities and schedule of works. As part of the devolved agenda, 2011/12 the NP received £163,789 of devolved budget to address issues relating to local minor traffic schemes, carriageways and footways. In addition to the devolved core budgets, since 1st April 2011, the NP agreed to take responsibility for section 106. At present there is £114,670 of Section 106 money available to support specific local traffic schemes in this Neighbourhood Partnership area.

Environment & Street Scene; this section mainly deals with issues relating to street scene, general environment improvements, parks and open spaces. The emphasis is to influence the services provided by the parks department and SITA. As part of the devolved agenda there is £1,500 of Bristol Clean and Green devolved budget to carry out environmental improvements. There is also an opportunity to bid for part of a citywide fund of money. In addition to the devolved Bristol Clean and Green budget, at present there is a further £149,185.53 of Section 106 money devolved to Neighbourhood Partnership to support the Greater Fishponds Area Green Space Investment Plan, currently being written.

#### iii- Methodology

The Action Plan consists of community issues and aspirations raised at various different engagement activities. They are brought and shared with the community at Neighbourhood Forums (NFs). NFs are open public meetings, which are held quarterly in each ward. Across the patch there are 12 NF per year. Anyone living or working in Greater Fishponds NP area can come to raise an issue or a community priority. Any issue raised at these meetings are dealt with by an appropriate agency (police/Bristol City Council, etc). They then report back progress at the next NF.

Persistent issues and community aspirations brought to the Neighbourhood Forums are also taken to the appropriate subgroups. There are three

subgroups in the Greater Fishponds NP area, namely Traffic and Transport, Greater Fishponds Planning and Environment and Street Scene. Members of the subgroups are local resident volunteers, supported by BCC Neighbourhood Teams. Their role is to sift through local community priorities and produce a work plan based on the issues and community aspirations brought to the NFs. The subgroups work plays an integral part of the NP Action Plan. The Action Plan is reviewed once a year to agree the annual work programme of the Neighbourhood Partnership and is signed off by the Neighbourhood Committee (local councillors) for all devolved service priorities, whereas the Neighbourhood Partnership Board signs off all other non devolved priorities.
