Please note: The Older People Wellbeing Fund has all been committed. At the last NP meeting the above shown £360 have been allocated to Colliers Gardens for a pilot project aiming to reduce isolation among older people living the in the NP area.

1. The Wellbeing Panel met on Monday 20th February 2012 and considered 1 application. This was later put through to councillors for decision. Summary appraisal sheet for this application is shown in Appendix A page 45.

- 2. In June 2010, the partnership agreed to process applications from local community groups, which qualify for "exceptional circumstance" criteria. The maximum amount groups could apply for under the exceptional circumstance was caped £1,000. The purpose of this was to support local community groups who plan to organise a community event/activity in the area.
- 3. Three community groups have been supported using this process. These are:

In total £1,560 have been committed by the Neighbourhood Committee (NC), since the last Neighbourhood Partnership meeting.

Legal Information

When councillors decide how the wellbeing fund is spent they should have due regard to the public sector equality duty that applies to all public bodies. This duty is contained in the Equality Act 2010 and came in to force on 6 April 2011. It replaces previous equality duties under the Sex Discrimination, Race Relations and Disability Discrimination Acts.

The duty means that councillors are required to have due regard to the need to:

- Eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited under the Act
- Promote equality of opportunity between different groups
- Foster good relations between people from different groups

The duty covers the following protected characteristics:

- Disability
- Sexual orientation
- Age
- · Gender reassignment
- Religion and belief
- Sex
- Race
- Pregnancy and maternity

It also applies to marriage and civil partnership, but only in respect of the requirement to eliminate discrimination and harassment.
