# 1. Highways Schemes

1.1 Up-Date on 2012/13 Highways schemes

#### 1.3 Underspend from 2011/12 schemes.

- Froomshaw Road (Feasibility NP017), This scheme is outstanding from 2010/11 devolved local traffic schemes. Vehicle counts were carried out during November 2010. The results do not support the reported excessive movement of vehicles turning off Begbrook Park to avoid the roundabout on Frenchay Park Road. Second count has also been carried out resulting in very similar figures. It is hereby recommended that road closure or one-way proposals are not progressed at this stage and to only continue with parking restrictions.
- In total £7,435.82 of underspend is coming back to the NP Local Traffic schemes pot. This is mainly because some of the schemes were was over estimated, e.g. Froomshaw Rd and Forest Rd feasibility study.
- In total £1,546.16 of Minor Lines & Signs and £9,839.03 of all other schemes will be carried forward into 2012/13.

### 1.4 The Neighbourhood Committee is asked to agree to pay for overspends in 2011/12

- Frenchay Area Parking Restriction: This scheme was funded from 2010/11 Local traffic scheme budget. Works started on site in early May 2012 and is due to be completed soon. This scheme was originally estimated to cost £5,000 and is now expected to cost £12,278.22. This is mainly because the scheme was slightly widened and due to its close proximity to Frenchay Hospital, it attracted a number of objections, which as a result impacted on the estimated cost of the scheme. The scheme now requires further £7,278.22. It is hereby recommended for the Neighbourhood Committee to approve £7,278.22 from the Local Traffic budget to deliver the scheme.
- The Vassall Rd: The scheme was originally estimated to cost £5,000. The final cost of the scheme is £5,922.98. UWE paid for the full cost of the scheme. No action is required from the Neighbourhood Committee.
- Snowdon Rd Parking Restriction: This scheme was originally estimated to cost £5,000. It is now estimated to cost £7,644.59. This is mainly due to objections received. The Traffic Regulating Order (TRO) for the waiting restrictions associated with 41 Manor Rd scheme was incorporated into the scheme.

It is hereby recommended that the Section 106 on 41 Manor Rd is used to offset for the overspend. The Neighbourhood Committee is hereby asked to approve the release of £3,144.11, which will be used to pay for the cost of the TRO and remaining amount will be set-aside for maintenance cost for the traffic island.

• Charlton Rd Area Parking restriction: Originally the Neighbourhood Committee approved £5,000, £2,600 from Local Traffic Scheme and £2,400 from Section 106. Further £4,000 is required to deliver the scheme and it is hereby recommended that the Neighbourhood Committee approve £4,000 from devolved local traffic scheme in order to deliver this scheme.

### 3- Subgroup proposal

The Environment subgroup met on Thursday 7<sup>th</sup> of June 2012. The group proposed to use devolved Clean and Green money to replace Lime Tree in Eastville Park, if Community Tree Planting programme is unable to replace this tree. The group also proposed to use section 106 to enhance the entrance of East Park Open space.

The Neighbourhood Committee is asked to approve to:

- 3.1 Spend £330 from Clean and Green devolved budget to replace Lime tree in Eastville Park, if this is not supported from Community Tree Planting programme.
- 3.2 Spend £1,750 from the devolved Section 106 to improve access to East Park open space via the Greenbank View. This will compliment plans for the quick win money allocated to the area. See Appendix XXX
