Activity 4: Improve habitats: Develop and deliver Tree Plans and planting schemes in Eastville Park and Frome Valley.		The Big Tree Plant's millionth tree plant took place at Eastville Park on February 5 th 2015 as part of the TreePips project. 60 children from Glenfrome school were involved in the planting and the day was attended by the Secretary of State for the Environment, The Mayor, Director of the Tree Council and the Chair of the Forestry Commission.
		The plan was developed with the Friends of Eastville Park

and 28 standard trees were planted following a wide community consultation.
The plan also has 17 further trees which can be planted next season (Dec 15 – March17) subject to funding via NPs, memorial or business sponsorship being found at a cost of £275 a tree including 2 years of watering, totalling £4,675.
Of these further trees, 10 are in an avenue across the middle of the park to mirror an existing avenue. There is an issue with these - although approved by the community consultation, there are now permanent football goal concrete bases that are in place which will need to be removed at an approx. cost of £3,000 each. This needs to be followed up at a community level/NP level before planting of these 10 can take place.

Hockey's Lane Statement

Background

- Left turn into Hockey's Lane banned as part of Greater Bristol Bus Network scheme in 2011
- Concerns raised re drivers ignoring the left turn ban and turning through the green man
- Various actions taken including police enforcement, increased visibility of banned turn signs, roundel on road and traffic studies
- Number of vehicles ignoring the banned turn dropped significantly
- No reported accidents involving pedestrians in the three years since the turn was banned

Current Position

Hockey's Lane is a key junction on the Fishponds Rd GBBN route and as such determines the operation of the traffic signals along the whole corridor. Various options have been explored for removal of the banned left turn. The only feasible option other than retaining the left turn ban is to remove the ban and change the pedestrian crossing to an all-round pedestrian stage where all traffic is stopped to allow pedestrians to cross the road. This would have the following impacts:

• Reduced capacity at junction

Aside from increasing congestion along the Fishponds Rd corridor this would also negatively affect the signals on the rest of the corridor – particularly the pedestrian crossings. This would result in longer delays for pedestrians at these crossings

• Delays to buses

Queues on Fishponds Rd would extend beyond the ends of the existing bus lanes delaying buses attempting to enter them. Buses would also suffer some minor delays at the junction itself due to vehicles queuing in the bus lane to turn left.

• Reduced green man time for pedestrians

Pedestrian delays would be increased at the junction and pedestrians would receive a much shorter green man time

• Morrisons traffic may divert to this route

Currently over 90% of Morrisons traffic uses the prescribed route via Station Rd to access the store. Traffic diverting away from this route to Hockey's Lane would benefit frontages along Station Rd but would also increase traffic levels and therefore congestion on Fishponds Rd

Removing the left turn ban would have a significant impact on the area as a whole as detailed above. Whilst it is accepted that driver behaviour is creating a hazard, the hazard is not significant enough to warrant removal of the left turn. Other hazards would be created by removing the left turn ban and the impacts on bus reliability and journey times would be significant. It has therefore been decided to retain the left turn ban and leave the junction layout as it is currently.

Future Options / Mitigation

The government may at some point decriminalise the contravention of banned turn movements enabling the council to enforce this banned turn with CCTV cameras. If this happens the council will commit to enforcing this banned movement to further reduce the hazard at this site.

Currently this is the only safe crossing point of Hockey's Lane. As a new library has opened at the end of Hockey's Lane, pedestrian movements have increased. There is therefore justification for creating an additional crossing point on Hockey's Lane at the existing dropped kerbs by Lower Station Rd. This would remove some of the pedestrian movements currently occurring at the crossing by Fishponds Rd reducing the hazard at that point. An uncontrolled pedestrian crossing island could be provided for £5k or a zebra crossing could be provided for £10k if budget is made available.
