Eg hotspot locations: Railway path, East Park and Boswell Street and area in the triangle between M32 and fishponds road.		Residents in Lower Eastville have been given support in doing litter picking and clearance of rubbish in the area. They have been actively reporting fly tipping and there is a noticeable improvement in the general cleanliness of the area. We are currently contacting the owners of the land at the bottom of Freemantle looking at creating a community space. Community Development officer has started work with the skaters under the M32 to address the management of this space, note there has been increase in people rough sleeping in the locations as some of the ramps are

		problematic.

These have been done taking comments on board from residents and other interested parties. Around 350 properties leafleted in the area including Little Hayes and Goffenton Drive, to invite them to a viewing of the proposals on the Saturday 5th December at the Vassell Centre. After this Bristol Parks will look to place a planning application for the proposed overflow car park before Christmas 2015 and if this is successful then we would look to start work in early 2016 so that the car park can be operational during the busy summer months of 2016.

Raquib Khandker Community Development Worker instigated the first stages of an Assed Based Community Development project in East Park. He met with East Park Resident Association and is supporting the group to organise an event to celebrate the new children play area with them. The date of next meeting is on Thursday 3rd December 15 between 6pm-7pm. Another local residents led group called 'Eastville Workhouse Memorial Group' organised memorial stone unveiling ceremony, which was held on 16 th November 2015 at 11 O'clock. Over a hundred residents including children from May Park school and council officers attended the event. Images from the ceremony have been uploaded on to East Park Residents Association Facebook page. DW in regular contact with disabled residents interested in gardening. Also meeting one of the key people involved in the M32 skate area on Tuesday 1 st December 2015 to explore aspirations and options for the site.
Activity 2: Support and empower local residents wanting to set-up friends of parks for all the parks and open spaces. Advising about policies and constitution matters. Target Begbrook and Ridgeway Playing Fields.		DW has recently started to market an unloved piece of council owned land just off Ash Grove to local residents and community groups.
