#### 1. Purpose of this Paper

To update members of the Health and Wellbeing Board on the proposed programme and structure of the Bristol Alcohol Misuse Summit planned for 16 July 2015 and to seek endorsement of the planned approach.

#### 2. Executive Summary

Bristol Health and Wellbeing Board is co-hosting an event aimed at bringing people together across the city to discuss a city-wide strategic approach to tackling the harm caused by alcohol misuse in the city.

#### 3. Context

- 3.1 In common with many parts of the UK, the effect of alcohol misuse has major negative impacts on health, crime and anti-social behaviour, and our economy.
- 3.2 The total annual cost to society of alcohol-related harm is estimated to be £21bn in England **(1)**. Alcohol – misuse led to almost 1 million alcohol-related violent crimes and

1.2 million alcohol-related hospital admissions in 2010/11 alone. Up to 17 million working days are lost each year because of alcohol-related sickness and the cost to employers of sick days due to drink is estimated at £1.7bn (2). Furthermore, liver disease is the only major killer that is still increasing, with deaths from liver disease having risen by 40% between 2001 and 2012.

3.3 Recognizing that there is a vast amount of expertise in the city in tackling this issue and much activity already taking place, the aim of the summit is to discuss what else we could and should be doing collectively to tackle this issue. This could be local initiatives, but also cover what we need to ask of Government.

3.4 This will range right across all aspects of this issue, from prevention to treatment and licensing to alcohol-related crime.

#### **4. Draft Programme**

4.1 The draft programme will be circulated at the meeting. Appendix A is the current list of invitees. Appendix B refers to the 'high impact interventions' published by the Department of Health.

#### **5. Key Risks and Opportunities**

5.1 A key risk is that some partners are unable to attend.

5.2 The summit is an opportunity for all partners to engage in a comprehensive discussion about alcohol issues in Bristol.

#### **6. Recommendations**

6.1 Board members are asked to discuss and agree the format and approach of the programme for the summit.

6.1 It is recommended that all members of the HWB make every effort to attend the alcohol summit.
