1.5. Wellbeing Grant monitoring information return and further payment of Wellbeing grants

- 1.5.1 All NP Co-ordinators have been asked to focus on enforcing the Wellbeing Fund agreement made on payment of all grants that the recipient organisation must return monitoring information when asked to do so.
- 1.5.2 An 'amnesty' is being implemented on all Wellbeing funding prior to April 2014/15. All organisations who received Wellbeing Grants from April 2014 onwards are being contacted and asked to supply monitoring. Some have responded and some have not.
- 1.5.3 The Wellbeing Assessment Panels discussed this topic and the consensus reached was that no further Wellbeing Funding should be paid to any organisation which has outstanding monitoring from 2014/15 onwards.

1.5.4 Recommendation: that the Councillors on the Committee request to NP Co-ordinator to contact all groups with outstanding monitoring from 2014 onwards and a. require them to submit monitoring by the end April 2016 (expect where their project has not yet finished); that any project which has been granted Wellbeing at the March 2016 NP meeting should have payment of their funding held back until they have completed all outstanding monitoring to the satisfaction of the NP Co-ordinator; that any group which fails to complete outstanding monitoring by the end April 2016 should a. be required to repay part or all of their Wellbeing Grant, as set out in the Funding Agreement and b. should be disallowed from receiving further Wellbeing throughout 2016/17.

Item 2: Parks and Green Space Priorities: Developments and Opportunities

- 2.1 Bristol City Council held an event on Saturday 27th February to publicise a new annual funding stream for Parks and Open Spaces of £500,000 per year and a one-off Access Fund of £250,000. The City Council has linked spend from both these funds directly and exclusively to the priorities set out in Neighbourhood Partnership Plans
- 2.2 A Henbury and Brentry PIP working group met again on 3rd February 2016 to develop a Henbury/Brentry Parks and Green Spaces Investment Priorities Plan ('PIP'). The group agreed on a set of ideas from those which have been suggested from previous community conversations in the last 3 or 4 years as the basis for a community survey to sound out residents priorities. This will be the basis on which priorities will be brought to the June 2016 NP meeting for adoption as NP Plan priorities
- 2.3 Adoption of initial priorities for Henbury & Brentry:

Recommendation: The PIP working group recommends to the NP the adoption of the following initial priority for Henbury/Brentry Parks in the NP Plan:

- Crow Lane Play Area: The installation of fencing and access gate around the new play equipment installed as part of the Capital Stimulus Fund in 2013/14
- 2.4 Adoption of Henbury/Brentry and Southmead Access priorities:

Recommendation: The Henbury/Brentry PIP Working Group recommends the following initial access priorities for Henbury/Brentry for approval by the Neighbourhood Partnership for inclusion into the NP Plan:

 Crow Ln Play area – improve Disabled access to the play area (gate and pathway) and install disabled-friendly children's swing and able-bodied swing set

Research by Ian Popperwell, the researcher commissioned by the Fourteen Fund to explore the needs of disabled people in Southmead has identified access priorities to Parks and Open Spaces.

Recommendation: That the Neighbourhood Partnership adopts the following priorities to improve access to Southmead Parks and Open Spaces for inclusion into the NP Plan:

- improving the accessibility of as many entrances as possible to the Doncaster Road Park and Badocks Wood entrances
- 2.5 Equalities Impact Assessment and Community influence:
 - The request for fencing at Crow Lane voiced in a consultation held at the Henbury/Brentry Fun Day in August 2015; this consultation also included the request for disabled swings installation in Crow Lane play area.
 - The positive equalities impact of both these pieces of work are: safer, cleaner play for children & parents because dogs will not be able to access or soil the play area; the disabled-friendly swings will enable disabled children and their carers to use and enjoy the play area alongside non-disabled children, promoting inclusive play and integration/equality of access between both groups
 - The Access recommendations for Southmead have been made before; the disability research project has amplified these requests from both disabled and non-disabled people. The positive impact of improved access gates is that disabled people using wheelchairs/mobility scooters and parents/carers with children in double buggies will be able to achieve equal access to two major park areas for both play and recreation in Southmead alongside able-bodied users.
 - o The potential disadvantage to all parks users of inclusive access to these parks/open spaces is its abuse by motorbike/scooter users to illegally ride their vehicles within the park spaces, creating ASB and noise nuisance and destruction of park habitat. This needs to be carefully explored and options to mitigate this risk considered and adopted. One such option might be the closure of the 'full access' entrance at night.

Item 3 NP 2016/17 Budget allocations:

- 3.1 The new Financial Year, 2016/2017, starts on 1st April. The NP has a nominal Neighbourhood Budget available to it as follows:
- £52,428 (made up of £17,143 from Highways; plus £11,099 remaining allocation in 2015/16 from former Narrow Estate Budget; plus the annual £2,686 uplift from former Narrow Estate Budget; plus former £1,500 Clean and Green; plus former £20,000 Wellbeing allocation)

Note: the actual operational budget may change, dependant on Highways underspends from final delivery costings, due to be reported at the June 2016 AGM NP meeting

- 3.2 Of this £52,428, £15,000 has already been committed to Highways delivery for Doncaster Road crossing installations. No Minor Signs and Lines work and Minor Works budget has been allocated for 2016/17.
- 3.3 This leaves £37,428 available in the NP Neighbourhood Budget to allocate to NP Plan priorities (plus any undisclosed Highways underspends and S106 and CIL contributions available (see Item 6, below)
- 3.4 Wellbeing Fund: the Wellbeing Fund has been consistently over-subscribed in recent years and helps engage local groups and organisations in contributing to the delivery of the NP Plan.
- 3.5 It's recommended, therefore, that the Councillors on the Neighbourhood Committee approve the reallocation of £20,000 of the Neighbourhood Budget to a Wellbeing Fund for the new ward area of Henbury, Brentry and Southmead for 2016/17
- 3.6 If 3.5 is approved there will be £17,428 remaining unallocated in the Neighbourhood Budget for 2016/17. In 2016/17 the NP also approved an allocation of £5,000 to a Community Environment Budget. This funded an enhanced hanging basket scheme in Crow Lane and Arneside. An underspend of £2,017.19 from this budget is being carried over from 2015/16 (due to NO absence in delivering spend).
- 3.7 Recommendation: that a further allocation of £2,500 is added to the Community Environment Budget to create a £4,517 fund for 2016/17

• That the same hanging basket display as in 2015 should be funded from this Budget (£2,880 last year)

Item 4. Exploring 2016/2017 Neighbourhood Budget allocations

- 4.1 There are a number of potential spends which the NP could consider to make use of the unallocated £ in the 2016/17 Neighbourhood Budget:
- 4.2 Both Traffic & Transport Sub-Group and Parks Priorities Groups are developing work which could use this unallocated funding
- 4.3 In addition, residents who attended the Neighbourhood Partnerships Parks Investment Workshop on Saturday 27th February will have heard how St George's NP has used its additional Narrow Estate Road funding to commission a Fundraiser to raise funds to support its Parks Investment Priorities. To date they've raised a minimum of £182,000 through this investment and more fundraising is in process so this figure is likely to increase. This is an example of initiative and creative use of Neighbourhood Budgets which the removal of the Council's ringfencing was intended to enable.
- 4.4 Given the above range of options (and there are more, of course) the Neighbourhood Partnership Coordinator recommends that the NP sets up a Governance/NP development event to report back to the 28th June NP AGM meeting with recommendations for use of the unallocated Neighbourhood Budget.
- 4.5 Recommendation: that the NP agrees the setting up of a re-arranged Governance/NP development event between March and June 2016 to include consideration of a range of options for use of its Neighbourhood Budget to report back to the AGM NP Meeting on 28th June with recommendations

Item 5: Highways Schemes & Traffic & Transport sub-group recommendations

5.1 The Traffic and Transport Sub-Group was intending to meet in February 2016 to develop scheme recommendations

for a local traffic scheme for 2016/17.

5.2 This meeting has not taken place, however.

It's recommended, therefore, that this meeting take place between March and June to enable a set of recommendations to be brought to the 28th June NP meeting for decision. An advantage of this delay is that Highways final costings for the schemes they've delivered to NPs across the last two years are intended to be available and the NP can include accurate underspend sums when considering which scheme it wants to adopt for 2016/17

Item 7: Legal Information

When councillors decide how the wellbeing fund (or any other NP Budget) is spent they should have due regard to the Public Sector Equality Duty that applies to all public bodies. This duty is contained in the Equality Act 2010 and came in to force on 6 April 2011. It replaces previous equality duties under the Sex Discrimination, Race Relations and Disability Discrimination Acts.

The duty means that councillors are required to have due regard to the need to:

- Eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited under the Act
- · Promote equality of opportunity between different groups
- Foster good relations between people from different groups

The duty covers the following protected characteristics:

- Disability
- Sexual orientation
- Age
- Gender reassignment
- Religion and belief
- Sex
- Race
- · Pregnancy and maternity

It also applies to marriage and civil partnership, but only in respect of the requirement to eliminate discrimination and harassment.
