Recommendations

To note the updates and progress on devolved budget spend.

1. Devolved Highways Budgets

1.1 Local Traffic Schemes

Budget: £26,400.03

(£17,143 plus £9,257.03 carried over)

New Fosseway Road (Hengrove)	Introduce parking restrictions	£5,000	Limited waiting parking restriction scheme outside Post Office has recently been circulated through public design consultation. Responses currently being reviewed so that scheme can be issued to TRO Team for progression.
Stockwood Lane (Stockwood)	Carry out design and consultation on potential traffic calming measures	£5,000	Feasibility study complete and has been circulated to councillors and at Forums. Recommendations to be considered as part of devolved budget process.

Local traffic schemes shortlist for 2012-13

Budget: Not yet confirmed but anticipated to be the same as previous years $\pounds 17,143$.

Forum sessions have taken place to establish a shortlist for local traffic scheme investment in 2012-13. A list of all of the forum issues, issues that have been directly reported to Highways officers and issues that have been reported to councillors were considered and action planned. These action plans will be available at February's forums.

The short list for investment next year is as follows:

Hengrove

- 1. Double yellow lines and timed parking bays in Petherton Road between Wells Road and Dennor Park (approx £5,000)
- 2. Pedestrian refuge island on Walsh Avenue to assist school crossing and other road users (approx £5,000-8,000)
- 3. Tarnock Avenue realign road to prevent nuisance parking (approx £2,000)
- 4. Double yellow lines from the bus stop on Fortfield Road up to and around the corner of Wharncliffe Gardens (approx £4,000).

Stockwood

1. Outcomes of Stockwood Lane feasibility study – likely to be parking

restrictions (cost not known)

- 2. Bifield Road end of Townsend Road opposite junction also junction into Burfoote Gardens from Bifield – parking restriction review and implementation. (approx £5,000)
- 3. Mowbury Green/Wells Road Junction down to garages extend double yellow line to prevent issues with wells road junction and obstruction to garages (approx £4,000)
- 4. Cowling Drive additional recessed parking similar to north side (cost not known)

The next steps are for Highways officers to provide accurate costs for the schemes and to present a report in March with costs for the shortlisted schemes for the Neighbourhood Committee to make their decisions. Where appropriate, schemes will be combined to reduce costs (for example using one scheme to address both Petherton Road and Mowbray Road parking issues).

4. Section 106 budgets

a. Parks s106 budgets

£41,828.41 for improvements to parks and open spaces within 1 mile of the former Tarnock Avenue prefab site. See agenda item 9 for an update on this spend.

£35,274.34 for ecological mitigation in the vicinity of the Community Hospital.

This project has not yet been progressed

Up to £13,000 underspend from BMX track in Stockwood. See agenda item 9 for proposed process for spending this money.

b. s106 budgets for transport

£44,674.46 allocated to bus stop improvements on Oatlands Avenue and Fortfield Road (4 stops to be improved, all 4 stops service the 20 and 51 buses). Works to the bus stops include:

- installing raised boarding platforms to latest standards
- installing real-time-information displays (including electrical connections)
- clearway markings to protect the stops for buses to pull in Works are due to be complete in January.

£144,611.63 for community transport to link surrounding communities to the Hengrove Community Hospital – see agenda item 7

£15,059.90 for directional signage to the Hengrove Park site – this project has not yet been progressed.
