## 30.1/12 AREA CO-ORDINATOR'S REPORT ON DEVOLVED BUDGETS

The Neighbourhood Partnership received a report of the Area Co-ordinator (Agenda Item No. 5) noting the updates and progress on devolved budget spend.

Gemma Dando introduced this report and summarised it

for everyone. Referring to the statement submitted by Bill Kent, she advised everyone that work on Petherton Road is on the short list for investment next year and a decision will be made at the N P Meeting on 20<sup>th</sup> March 2012. In response to comments and questions she confirmed that she would e-mail everyone with the details of potential schemes for next year.

In response to comments and questions, Gemma Dando confirmed that she would provide information about the spending of S106 money on community facilities and details of the venues for future NP and N F Meetings as these become available. Ariaf Hussain confirmed that all of the venues for the N F Meetings were booked.

## 31.1/12 S106 DEVOLVED BUDGET FOR PUBLIC ARTS

#### 32.1/12 S106 DEVOLVED BUDGET FOR COMMUNITY TRANSPORT TO SERVICE THE SOUTH BRISTOL HOSPITAL

The Neighbourhood Partnership received a report (Agenda Item No. 7) setting out the S106 devolved budget for community transport to service the South Bristol Community Hospital.

Pete Woodhouse introduced this report and summarised it for everyone. He confirmed that he was seeking in principle agreement to taking the approach of using existing community transport organisations to deliver community transport the new South Bristol Community Hospital, with a report containing arrangements and budgets and seeking final approval to be presented to the N P at its Meeting on 20<sup>th</sup> March 2012.

During the debate and questioning that followed it was acknowledged that there are problems with public Transport and Community Transport in the south of Bristol, but this report is only concerning the Community Transport Services. Public Transport issues will be addressed separately.

RESOLVED - (i) that the approach described at the meeting of using existing community transport organisations to deliver Community Transport Services to the new South Bristol Community Hospital be agreed; and (ii) that a further report seeking final approval for the spend of the devolved s106 budget - containing full details of the provision of community transport to the hospital and a financial breakdown of how the money is proposed to be spent will be presented to the N P at its Meeting on 20<sup>th</sup> March 2012.

The Neighbourhood Partnership received a report (Agenda Item No. 11 highlighting the work of a variety of different partnership members including local residents, community groups, councillors and partners such as the police and the council.

Inspector Salmon introduced the report and summarised it for everyone.

He drew attention to the fact that Parks are withdrawing their funding from the Operation Biker initiative from 1<sup>st</sup> April 2012. He advised that some N P's have agreed to provide funding of £500 per Ward from their Wellbeing Budgets to make up the shortfall.

Concerns were expressed about the withdrawal of the funding and the adverse affects that this could have on the area.

Following a debate Councillor Doubell moved that funding of £500 per Ward be provided from the Wellbeing Budget for the Operation Biker initiative and that attempts be made to recover this money from the Parks Budget.

Councillor Clark seconded this and on being put to the Vote it was CARRIED.

Inspector Salmon advised that the CCTV cameras are to be removed from the Hengrove Complex communal areas and this a safety concern.
