2. Anti-Social behaviour

No area of Hengrove or Stockwood was identified by the last BCC/Police city wide Ant-Social Behaviour audit as a significant hotspot.

Discussions are ongoing to replace funding for the continuance of Operation Biker the South Bristol initiative to tackle anti-social behaviour on motorcycles in Parks and Opens Spaces. The remainder of the budget for 2011/2012, was used in early March 2012 to address escalation in calls to Hengrove Park.

The recording criteria for ASB calls changed in the summer 2011 and therefore year to year comparison data will not be available until June 2012.

3. Local impact of funding

Avon and Somerset police have announced they will no longer have NHW administrators. Interaction with NHWs will be managed by local Neighbourhood Officers through a new contacts service.

The number of School Beat Managers across Bristol is being reduced.

5. Escalated Action Plans – from local crime trends or community priorities.

There are no escalated action plans for the area at this time.

Since last update, BCC have confirmed they will be retaining CCTV coverage as the new Hen grove Leisure Complex/Hospital/College which is now 2/3rds open. The Leisure complex has submitted a late request to be licensed premises. The opening of these premises could impact on crime figures for the area in the next 12 months.
