## 1. Devolved Highways Budgets

1.1 Minor Traffic Schemes

Budget: £26,400.03

(£17,143 plus £9,257.03 carried over)

# 4. Section 106 budgets

### a. Parks s106 budgets

£21,290 for improvements to parks and open spaces within 1 mile of the former Tarnock Avenue prefab site and £13,858.14 remaining underspend from the BMX track in Stockwood.

Suggested investments for Whitchurch Green are still awaiting approval from legal services to ensure that they comply with the new Town and Village Green status.

A parks investment plan is currently being developed and will be presented to the Neighbourhood Partnership in June to help inform spend of the remaining s106 budgets for the Hengrove and Stockwood Neighbourhood Partnership Area.

£35,274.34 devolved s106 budget for ecological mitigation in the vicinity of the Community Hospital. This project has not yet been progressed.

### b. s106 budgets for transport

£44,674.46 allocated to bus stop improvements on Oatlands Avenue and Fortfield Road (4 stops to be improved, all 4 stops service the 20 and 51 buses). Works to the bus stops include:

- installing raised boarding platforms to latest standards
- installing real-time-information displays (including electrical connections)
- clearway markings to protect the stops for buses to pull in

Initial survey work has been carried out by the Engineers at all four of the stops, and the next phase of the works will commence in April 2012.

£144,611.63 for community transport to link surrounding communities to the Hengrove Community Hospital. Update to be given at the Neighbourhood Partnership meeting.

£15,059.90 for directional signage to the Hengrove Park site – this project has not yet been progressed.

c. s106 budgets for public art: £269,994.29
