1. Name of Neighbourhood Partnership and Neighbourhood Forums

- 1.1 The Neighbourhood Partnership has had a request that it look s at changing its name to incorporate Whitchurch within its title.
- 1.2 There are arguments for and against changing the name.
- 1.3 At the NP briefing meeting on 4th June 2013 it was proposed that the Hengrove Forum changes it name to Hengrove & Whitchurch Forum.
- 1.4 It was further proposed that at the NP meeting on 24th June 2013, there is a discussion on changing the name of the NP with agreement from the NP membership.
- 1.5 It is suggested that the NP changes its name to the Stockwood, Hengrove & Whitchurch Neighbourhood Partnership.
