HSNP 6.6/13 NEIGHBOURHOOD PARTNERSHIP REVIEW UPDATE

The Neighbourhood Partnership considered a report of the Service Manager, Neighbourhood Partnership and Neighbourhood Working (Agenda Item No. 6) updating on the Neighbourhood Partnership review.

Gemma Dando introduced the report and summarised it for everyone.

During discussion of the report the following points were highlighted:

- The issue of timescales for projects was raised during the review
- There is a need to develop a strategy so that residents' view can be taken into account in the planning process.
- Publicity is generated by a number of means including through e-mails, Forums and community facilities
- BCC Officers attend Meetings for specific agenda items
- RESOLVED (1) that the Mayor George Ferguson's statement about the future for NPs be noted;
 - (2) that the outcomes of the consultation and the proposals for the next stages of the N P review be noted; and
 - (3) that the N P agreed to

implement local improvements and engage with the citywide review implementation.

HSNP 7.6/13 NEIGHBOURHOOD PARTNERSHIP AGM REPORT

The Neighbourhood Partnership considered a report of the Area Co-ordinator (Agenda Item No. 7) setting out the Neighbourhood Partnership AGM report.

There was a debate about changing the name of the N P at the end of which it was agreed – on a vote – that the N P be renamed Stockwood, Hengrove and Whitchurch for an initial period of a year.

In relation to the N P's Resident Representatives, it was agreed that Bernard Price be invited to serve as a Cooptee for this year and that from next year each Ward be invited to elect 4 Representatives. It was also noted that there are on-going discussions Equalities Representatives.

- RESOLVED (1) that the N P be renamed Stockwood, Hengrove and Whitchurch for an initial period of a year;
 - (2) that as an addition to the Membership of the NP, Bernard Price be invited to serve as a Co-optee for this year and that from next year each Ward be invited to elect 4 Representatives;
 - (3) that the NC and NP terms of

reference and the NC financial operating framework be noted;

- (4) that the devolved budgets and influence on services be noted;
- (5) that the meeting schedule including sub-groups and forums be noted;
- (6) that the financial statement and expenditure from 2012/13 be noted; and
- (7) that the dates for updating the NP action plan and communications plan be noted.

HSNP 8.6/13 SECTION 106 – PUBLIC ART REPORT

The Neighbourhood Partnership considered a report of the Senior Public Art Officer, Bristol City Council and Theresa Bergne and Jes Fernie, Public Art Consultants (Agenda Item No. 8) setting out the section 106 public art report.

Jes Fernie introduced the report.

Theresa Bergne summarised the report for everyone and presented the 71 statements of support from local people for the Future Perfect Programme.

There was a debate during which some people expressed support for the project, whilst others expressed concerns about some elements of it. In particular it was felt that the participatory film project does not represent good value for money and that the orchard project should be led by a horticulturist. It was also considered that the enabling fund should be more than £10,000.

In response to these concerns and criticisms, it was explained that the project is only viable as a whole and cannot proceed with only one element of it; the orchard project can only be led by an artist and the artist is receiving advice from a horticulturist; BCC will only allow planting that is sustainable; the money has to be spent within a certain period and the art consultants have only been employed for a certain period; any extension of time and/or re-design will be cost more money; the consultation undertaken does not bear out the criticisms expressed and the consultants stated that there was a lot of support for all aspects of the project during the consultation process.

On being put to a Vote it was

RESOLVED - (1) that the permanent community orchard project be rejected;

(2) that the participatory film project be rejected;

(3) that the three-part small scale infrastructure project conceived by Nils Norman costing £49,000 be agreed;

(4) that the marketing programme to communicate the art programme to a local and national audience costing £16,000 be agreed; and

(5) that an enabling fund of at least £10,000 (exact amount be agreed) to accommodate small scale funding

requests for Hengrove based cultural projects to be administered according to guidelines developed by the Art Steering Group and agreed by the Neighbourhood Partnership be agreed.
