## 15.9/13 HIGHWAYS FOOTWAYS SCHEMES

The Neighbourhood Partnership considered a report of the Service Manager, Transport Services (Agenda Item No. 5) updating on the highways footways schemes.

In response to a question about surface dressing, Shaun Taylor explained that roads are swept within 24 hours of the work being completed with subsequent re-sweeps done over 7 days. He also explained that surface dressing much cheaper than resurfacing.
