4. The next Wellbeing deadline for applications is 22 May 2015, with the panel meeting on 2 June 2015 for recommendations to the NP meeting on 17 June 2015.

5. Previously, the Neighbourhood Partnership gave a grant of £4000 towards replacement chairs for the pews in Christ Church, Hengrove.

6. Also last year to again improve the facilities the NP provided a contribution towards an installed a new accessible toilet. The NP offered £1,500, but on the condition the chairs were in place by the end of March 2015.

7. Unfortunately whilst the church is in the process of putting in another application to replace the Pews with chairs, they will not be able to meet the March deadline.

8. There is a request from the church to the Neighbourhood Partnership to extend the deadline to December 2015.

### Legal Information

When councillors decide how the wellbeing fund is spent they should have due regard to the public sector equality duty that applies to all public bodies. This duty is contained in the Equality Act 2010 and came in to force on 6 April 2011. It replaces previous equality duties under the Sex Discrimination, Race Relations and Disability Discrimination Acts.

The duty means that councillors are required to have due regard to the need to:

- Eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited under the Act
- Promote equality of opportunity between different groups
- Foster good relations between people from different groups

The duty covers the following protected characteristics:

• Disability, Sexual orientation, Age, Gender reassignment, Religion and belief; Sex, Race, Pregnancy and maternity.

It also applies to marriage and civil partnership, but only in respect of the requirement to eliminate discrimination and harassment.
