Henleaze, Stoke Bishop and Westbury-on-Trym Neighbourhood Partnership 20 June 2012

Report from the Transport Working Group

1. Introduction

The Group's last quarterly Meeting was held at the Westbury-on-Trym Academy on 1 May. Notes of the Meeting have been circulated to all attendees (and Group Members) and can also be viewed on the NP's website (www.activenp.co.uk). The majority of the Meeting was devoted to prioritising the NP's Minor Traffic Schemes for 2012/13 (Item 4, below).

2. Greater Bristol Bus Network (GBBN)

Several concerns have been raised about the efficacy of the GBBN's Whiteladies Road/Westbury Road (A4018) route, both at the Working Group's last Meeting and at the most recent round of Forum Meetings in each of our 3 Wards.

There were 2 specific concerns with the GBBN's improvements executed within our NP area - primarily the Bus Lane in Westbury Road, on its approach to the Whitetree roundabout. In short, this appears to be a complete disaster that defies all definitions of being "fit for purpose". Even the results published in the GBBN's "Non-Statutory Consultation" acknowledged the very high number of negative responses to the original proposals. All this "negativity" was completely ignored in the Scheme's execution, as it was implemented unchanged.

The key problem is that, with effectively only one lane entering the roundabout, queues regularly stretch back to the top of Falcondale Road. This means that buses are now trapped with all the other queuing traffic on the approach to the start of the new bus lane, negating any potential benefit from it. Therefore, we would contend that the bus lane adds nothing to improving the free passage of buses heading towards Bristol and could be construed as making progress even slower.

Furthermore, the road layout on the immediate approach to the roundabout has created a dangerous situation for legitimate traffic using the bus lane (taxis, motorcyclists etc) that wishes to turn right at the roundabout into Parry's Lane. This traffic has to mix/merge with traffic already in the right hand lane which invariably leads to confrontational situations on the roundabout itself. This is an accident waiting to happen!

The second concern was apropos the new cycle lanes, where it is unclear as to whether or not all the road markings have been completed and audited, in particular the cycle contraflow at the North View end of Westbury Park. It is felt by some that the new layout is not obvious and could be confrontational with other road users. Some residents are of the opinion that the "improvements" were specifically "anti-car" in that the original 2-lane exit into North View has now been reduced to only one lane.

The GBBN Project Team Manager has been asked to comment on these concerns, specifically seeking clarification as to whether or not the original road layouts would be restored if the planned "improvements" have not been demonstrably achieved. Overall, we would welcome any quantitative feedback from the GBBN to indicate that the new arrangements are, in fact, an improvement!

3. Minor Traffic Schemes, Previously Approved by the NP

The majority of the work approved by the NP in June 2010 and March 2011, for implementation in 2010/11 and 2011/12 respectively, has been completed. The following approved schemes/feasibility studies are due for completion in the near future:

- 1. New parking restrictions at the Old Sneed Avenue junction with Stoke Hill, combined with other parking restrictions in Shirehampton Road (near its junctions with Sea Mills Lane and Stoke Paddock Road), Sea Mills Lane (leading to Sea Mills Station) and Kewstoke Road (outside the Village Hall) will be completed in the next few months.
- 2. Results from a feasibility study for the possible remodelling of the Passage Road/Greystoke Avenue junction, including traffic counts, are awaiting analysis and publication by BCC's Traffic Management Team.
- 3. A traffic signal sequencing review of the 4 sets of lights on Falcondale Road was completed in January. Results are currently being evaluated, ahead of publication, by BCC's Traffic Management Team.
- 4. A Parking Restriction Review and consultation in the areas of Etloe Road, St Albans Road, Royal Albert Road and Devonshire Road was completed last year. It is currently anticipated that implementation of new parking restrictions will be completed this autumn.

4. Minor Traffic Schemes, Prioritised for 2012/13

At the last NP, we were advised that funding of £25,714 was available for 2012/13. Together with unspent funding rolled-over from 2011/12, the NP will have approximately £28k to spend on Minor Traffic Schemes in 2012/13.

At the Transport Working Group's last Meeting, a total of 25 Highway Issues were considered for possible resolution and implementation in 2012/13. A copy of the full list is appended to this Report, updated to take account of the points raised during the Meeting's deliberations.

The following 25 Issues were prioritised, on a Ward by Ward basis, for implementation in 2012/13:

H112 (Westbury Road, near Brecon Road) – An additional Zebra Crossing had been requested but its necessity will be reviewed as part of the expansion of the St Ursula's School site.

H114 (Northumbria Drive, entrance to Waitrose) – This is a problem of pedestrian safety with vehicles entering/exiting the car park over a pavement. There are approximately 40,000 vehicle movements per week. After much discussion, BCC's Traffic Management function will be requested to undertake traffic/pedestrian movement counts and draw up some layout proposals for this area, at a cost of £2k.

H115 (Henleaze Road, exit from Tesco) – Similar problem to H114. BCC's Traffic Management function will be asked to review the current layout, at cost of £2K.

H117 (Henleaze Road/Northumbria Drive mini roundabout) – The road markings have recently been repainted and a possible solution for traffic calming would be to build out the pavements to re-shape the junction. A design study would cost £4K, with implementation costing approx. £20K. However, this may be unnecessary if a 20mph speed limit is implemented in this area.

H118 (Park Grove) – Low usage does not warrant a Zebra Crossing but pavement build-outs may provide a practical solution. It would need a design study and a subsequent local consultation, at a cost of £3.5K. The school may contribute to implementation once this was completed.

H119 (Howard Road) – Complaint about speeding but this was to be put on hold to see if local, City-wide, 20mph limits would be implemented.

H120 (Westbury Park area) – Any Resident Parking Permit Schemes would be reviewed as part of an on-going City-wide initiative.

Priority Ranking for Henleaze: 1: H114 (£2K), 2: H115 (£2K), 3: H118 (£3.5K), 4: H117 (£4K).

S106 (Rockleaze, Downleaze and Circular Road) – Additional parking restrictions have been requested by the Downs Committee and bus operators. There is the possibility of some external funding from public transport operators, as this includes a bus route. It was suggested that passing places should be included in Circular Road. Cost of £3K for consultation and subsequent TRO.

S107 (Kewstoke Road) – Double yellow lines outside the Village Hall had been added to a TRO currently being progressed, at no additional cost.

S108 (West Dene) – Parking problems seem to have eased since the Coombe Dingle Sports Ground now use traffic cones to ameliorate bad parking at the junctions. Therefore, it was decided to put this issue on hold and review as necessary.

S110 (Parry's Lane/Abbey Gate) – A review of parking restrictions will be included with W112 (see below).

S111 & S113 (Cook's Folly Road & Seawalls Road) – A review of parking restrictions will be included with S106.

S114 (Stoke Road/Saville Road) – Additional parking restrictions on Stoke Road, approaching the traffic lights were essential to alleviating the current congestion. Also, double yellow lines should be included opposite the junction with Ladies Mile, which would also give a passing place on Stoke Road. Cost £2.5K for a TRO.

Priority Ranking for Stoke Bishop: 1: S114 (£2.5K), 2: S106 (£3K).

W101 (Passage Road/Greystoke Avenue junction) – Data from a recent traffic survey should be available by mid-June. However, the cost for implementing improvements would probably be in the order of £70-£80K.

W105 (Falcondale Road) – Recent traffic counts on this road have enabled the phasing of the traffic lights to be optimised to improve traffic flow. Discussion took place on the possibility of including an additional pedestrian refuge near the Greystoke Avenue junction (**W119**). It was felt that the results from the traffic counts should be tabled before any further progress can be made.

W108 (High Street) – Pedestrianisation (or part-pedestrianisation) was not within the budget of the NP and was put on hold until any plans were publicised.

W109 (Eastfield Road) – Footway improvements at the top of Waters Lane would cost approx £10K. This would improve safety for pedestrians and include a dropped-kerb crossing at the Village Hall. As the venue was used a great deal for weddings, events, etc, the Village Hall Committee should be consulted on any proposals. Users of the Hall needed to be able to unload their vehicles safely, without causing obstructions. A Design Study and consultation would cost approx £3K.

W112 (Stoke Lane Parking Review) – Primarily, the review was aimed at achieving safer parking at the junctions with Falcondale Road, Parry's Lane and some side roads, such as Great Brockeridge. There would be a consultation and it was emphasised that the shopkeepers <u>must</u> respond in order to voice their concerns or objections at the consultation stage. The review and consultation would cost approx £4K.

W114 (Chock Lane) – Concerns were expressed over the possible installation of a "speed hump" at the bottom of the road. The adjacent buildings were old and could be affected by vibration, as well as the noise. It was felt that all that could be done had been done to support "traffic calming" and this issue would now be put on hold and subject to review.

W115/W116 (Great Brockeridge & Reedley Road) – Would be included with W112.

W117 (Southmead Road) – The cost of a feasibility study for a Zebra Crossing near Alexandra Road would cost £1K, with a matching contribution of £1K from NP4. However, this sum could be revised to £1.5k per NP, if traffic counts are deemed necessary as part of the study.

W118 (Henbury Road, pavement parking opposite No 20) – This is a "grey area" with parking restrictions difficult to enforce. For £1K, steel demarcation studs could be installed to show the exact position of the pavement boundary, as an aid to parking enforcement.

W119 (Falcondale Road) – A pedestrian crossing may be necessary near Greystoke Ave as the number of pupils attending the new Free School increases. This issue would be kept under review.

Priority Ranking for Westbury-on-Trym: 1: W112 (£4K), 2: W109 (£3K), 3: W118 (£1K), 4: W117 (£1K).

In total, 10 Issues were prioritised for implementation in 2012/13, at a total cost of £26k. Taking account of the additional funding of £2k required for "Minor Signing and Lining", this total summates to the £28k available.

5. Carriageway Surface Dressing & Footway Resurfacing

At the last NP, we were advised that all Carriageway Surface Dressing schemes for our Neighbourhood Partnership in 2012/13 had been prioritised by BCC's Highways function and, therefore, the NP was not required to take any part in the prioritisation process. These proposals were endorsed by the NP.

In addition, the last NP approved Footway Resurfacing schemes in Stoke Grove (£37k), Glen Drive (£16k) and part of Springfield Grove (£13k) for 2012/13, from a budget of £63k. However, it has subsequently been reported that Glen Drive may be put on hold pending possible flood relief work in the area.

7. Recommendations

The Neighbourhood Partnership is requested to:

- 1. **Note** the on-going concerns regarding traffic problems resulting from the GBBN's improvements in our Neighbourhood Partnership area and **Approve** the request that the GBBN Team provide quantitative evidence that their scheme is demonstrably fit for purpose and has achieved its design intent (Item 2, above).
- 2. **Note** the current progress with minor traffic schemes previously sanctioned by the NP (Item 3, above).
- 3. **Approve** proposals for 10 minor traffic schemes, as detailed in Item 4, for implementation in 2012/13 from the NP's devolved budget.

Notes from 25th April: Agreed.

Matters Arising: There had been good feedback again from the last trip to Tea with the Lady Mayoress and they enjoyed the tour. Gay was concerned about the lady from Stow House, Shirehampton, who had asked to be included in future trips, as this was outside our area.
