# Henleaze, Stoke Bishop and Westbury-on-Trym Neighbourhood Partnership (NP3) 15 June 2015

## **Report from the Transport Working Group**

#### 1. Introduction

The Working Group's last quarterly Meeting was held at Westbury-on-Trym Academy on 29 April. Notes of the Meeting have been circulated to all attendees and can be viewed on the NP's website (<a href="www.activenp.co.uk">www.activenp.co.uk</a>).

As reported to the last NP Meeting in March, there continues to be a growing mood of frustration within the Transport Working Group resulting from there being insufficient resources available within BCC's Highways function to deliver the schemes previously sanctioned by the NP during the last four years.

However, the additional city-wide funding of £500k agreed in January to procure extra highway engineer resources in 2015/16 should help improve the situation and clear the current backlog of sanctioned minor traffic schemes.

Attachment 1, included in the Working Group's Report to the last NP, is reproduced again to highlight both the uncompleted sanctioned schemes and also indicates that the NP3 cumulative budget from 2010/11 to 2014/15 is £128,570, which should be compared to the cumulative "Committed" figure of £107,000. It will also be noted that the cumulative NP3 Outturn figure to date is "ZERO". As yet, the NP's Minor Traffic Schemes' budget for 2015/16 has not been confirmed but should be approximately £25k.

Until these Outturn figures are made available, the NP will have no idea of the underspend going forward. Such a figure is a prerequisite for our NP to be able to consider allocating any funds for the new "Minor Works + Minor Signing & Lining" category that was created by Highways for 2014/15 - but not defined absolutely. However, it is understood to include "minor works, signing and lining that does not require a TRO, or major Officer input".

At the last NP Meeting, The Area Manager (Highways) took Actions directed at resolving these issues and to report back to the June NP Meeting. However, at the time of writing (21 May) no updates have been provided.

#### 2. Greater Bristol Bus Network (GBBN)

The debate has continued as to the efficacy of the GBBN bus lane on the approach to the White Tree Roundabout. At last year's June NP Meeting, the Area Manager (Highways) took an Action to produce a "draft monitoring plan" to review the current situation. We continue to await the results of the monitoring survey (reportedly completed before the Christmas school holiday period) and, more importantly, any interpretation ascribed to the survey results. At the last NP Meeting, the Area Manager (Highways) took an Action to provide the results in time for this June's NP Meeting.

### 3. Cribbs/Patchway New Neighbourhood (CPNN)

There has been little in the way of significant Stakeholder involvement by BCC on their proposals for mitigating the effects of the CPNN development on the transport infrastructure in north Bristol. The last summary documentation, provided in February by BCC's Transport Development Manager, indicated that any mitigation proposals going forward were likely to be limited to wall-to-wall priority bus lanes along the whole of the A4018 corridor, plus the banning of right turns at all the outbound light-controlled junctions on Falcondale Road (with the exception of Canford Lane) and signalising the Old Crow Roundabout.

## 4. Minor Traffic Schemes

As highlighted in Section 1 of this Report, the NP has never been advised of any annual outturn figures for the Minor Traffic Schemes' budget - be that an underspend or an overspend going forward. Attachment 1 details ALL the schemes approved by NP3 since 2010/11 with their current status.

Until these Outturn figures are made available, the NP will have no idea of the underspend going forward. Therefore, it is currently impossible for our NP to consider allocating any funds for small schemes in the "Minor Works + Minor Signing & Lining" category that do not require a TRO, or major Officer input.

Attachment 2 ("Open Highway Issues") details the status of all 38 of the currently unfunded minor traffic schemes across our NP. This includes several potential minor works schemes. If there is a "real" cumulative underspend to date, then some of the "minor works" projects detailed in Attachment 2 could be funded now, such as:

- H137 Wellington Hill West Zebra Crossing upgrade (part funded with NP4)
- W109A Eastfield Road footway widening
- W121A Falcondale Road Zebra Crossing (Belisha Beacon halos and anti-skid surfacing)

It will be noted from Attachment 1 that there are currently 12 schemes with their status categorised as "on-going", ie not yet completed. Some of these schemes were sanctioned back in 2011/12.

However, on a more positive note, work on traffic-calming measures in Chock Lane (W114), dropped kerbs in Eastfield Road (W109) and additional "No Entry" signing in Channells Hill (W137, minor signing & lining) is due to commence in early June and be completed by the end of June.

Also, new parking restrictions in Sneyd Park – included as part of the much larger "Downs Parking Review" – should now be implemented, following completion of the Statutory Consultation at the end of May.

#### 5. Footway Refurbishment Schemes

With effect from April this year, the responsibility for prioritising footway refurbishment and surface dressing schemes will no longer rest with the NP but has been returned to highway officers for city-wide prioritisation.

At the last NP Meeting, we were advised by the Area Manager (Highways) that the NP would receive schedules detailing the footway refurbishment and surface dressing

schemes that had been agreed for our NP area in 2015/16. However, as yet, this information has not been received but it could be presented to the June NP Meeting.

#### 6. Recommendations

#### The **Neighbourhood Partnership** is requested to:

- 1. **Note** the continued lack of budget monitoring for the NP's devolved minor traffic schemes, such that the level of available funding going forward for additional "minor works" projects is currently unknown (Item 1, above).
- 2. **Note** the lack of progress with publishing the results of the traffic survey that is a prelude to the possible removal of the remaining section of bus lane on the approach to the White Tree roundabout, or to justify its retention (Item 2, above).
- 3. **Note** the current lack of any major Stakeholder involvement with proposals to mitigate the potential impact of additional traffic volumes on the A4018, arising from the Cribbs/Patchway New Neighbourhood (CPNN) (Item 3, above).
- 4. **Note** that work on the long-awaited traffic-calming measures in Chock Lane is due to commence in early June, with completion by the end of June (Item 4, above).
- 5. **Note** that footway refurbishment and surface dressing schemes are no longer prioritised by the NP. Such schemes are now prioritised centrally and the NP advised accordingly (Item 5, above).
