# Westbury-on-Trym Neighbourhood Forum. Wednesday 13<sup>th</sup> May 2015

**Election.** David Mayer was elected as one of the four Ward Representative for the next two years. One vacancy remains unfilled.

**Proposed closure of Westbury library.** Geoff Gollop gave an update on the campaign to persuade BCC to change their proposal to close WoT library including leaflets to spread greater awareness and encouraging as many residents as possible to respond to the second stage consultation feedback form.

**Ward boundary changes.** Alan Aburrow explained that the Local Authority Boundary Commission had confirmed that following an impressive local public response, 480 for WoT as part of a total of 780 across the whole of Bristol, a new three Councillor Ward named Westbury on Trym and Henleaze would be formed with effect from May 2016.

Actions arising from previous Forum. Alan Aburrow gave a summary of the "You said –We did" report of 8 ongoing local issues contained within the pack of papers. Including: - Filton Development impact, Upgraded pedestrian crossing at the top of Falcondale Road, ongoing vandalism of the Gents Lavatory in the Village etc. Full details are available on our web site www.activenp.co.uk

**New issues.** An Open Forum raised 4 issues including: - 1) disused electrical substation on the PROW between Cooper Roar and Back Stoke Lane, 2) Need to wash Road signs, 3) Failure to provide necessary notice of Road closure at Shipley Road 4) and a request to receive advice on how to get BCC to replace street trees that have been cut down. For full details see our web site.

**Police feedback.** PC Kye Handy presented a report prepared by Joanne Robertson our new Beat Officer highlighting a fall in burglaries, an increase in Shed breaks, an increase in vehicle crime mainly from cars left unlocked and a appeal to help identify the owner of a White West Highland terrier that has bitten members of the public in Canford Park and Quarry Park.

**Planning issues.** Alan Aburrow gave a summary from the paper, prepared by the Westbury-on-Trym Society, included in the pack of papers; including proposals at Southfield Road, 69 High Street, Wesley College and 35 Passage Road. For full details see our web site.

Westbury in Bloom. Sue Boyd gave a review of the Floral Display proposals for

this year and repeated her request for volunteers to step forward to help.

**Feedback from NP Working Groups.** This paper was taken as read. For full details see our web site.

**Any other business.** Gary Brentnall gave an update on the Green Capital Arts Project, Hilary Long gave an update on her proposal to provide "Memorial Gates" in the New Canford Park Entrance funded by public subscription, and Mr R Murphy raised the matter of a potential H & S issue of the number of attendees at the Canford Park Firework display.

**Elections** that were due to take place were now not happening as we have the correct number of representatives. Wendy Hull would prefer to stand as the Neighbourhood Watch representative. Alan introduced the two new reps:

Peter Robottom, who was interested in planning and traffic management. He was also a Lay Minister at St Mary's.

Peter Weeks, whose background is business and financial management working with small businesses in Bristol. Also a member of St Mary's and other organisations.

## **Updates:**

a) **901 Bus:** Confusion had arisen after the last Open Forum. Pressure was put on Peter Mann (BCC Director of Highways) to reverse the decision not to pick up passengers on its route from the Park and Ride to Clifton. The NP was offered two stops in Stoke Bishop. Concern was initially raised about increased parking close to the Village Hall, affecting its use, so Church Road stop was agreed. This was later extended to both stops following pressure from residents. An up to date timetable is available at the Village Hall stop. This is a six-month trial running to August. Peter Abraham has written to Wessex 3 times for a timetable with no acknowledgement. The Council pays for this Park and Ride bus at a cost of £29.7K pa, in an agreement with Clifton, so to keep it running, please use it

- b)Roman Way parking. Some white lining on the corner had been installed, which is discretionary, but appears to be working in preventing drivers parking on the corner and restricting access. It was asked if this could also be done in Hadrian Close where there is a solid line of parked cars during the week, but none at weekends. Unfortunately, the station does not have a car park. There followed a discussion about whether a car park could be put where the pre-fabs had been, or under the bridge. Alan Aburrow to attempt to obtain costings. There have been Roman remains found on the pre-fab site which was under review, and the grass area was likely to be statutory "open space" and would need Government approval to change it. Mark Sperduty (BCC Highways) is looking into the area.
- c) **Parking on the Downs:** This is out for final consultation and comments must be made by the 26<sup>th</sup> May. The plan includes 4-hourly parking with no charges, some displacing of parking, and some double yellow lines to enable buses access. All information is on the NP website www.activenp.co.uk.

From the floor: Saville Road/Circular Road – parking restrictions would be too intrusive and not necessary. The University needs to do something about the student parking. There are different varieties of pressures on different parts of the Down. It was suggested to put double yellow lines down one side of Stoke Road. This was suggested by our Councillors at the beginning of the procedure but it had been rejected. Widening the road was not an option as the Downs Committee had objected as it would encroach on Downs land. What would be the impact on Stoke Bishop? If it is awful, and roads are full, would we be getting the RPZ scheme? The councillors said this was their fear. It would be taken step by step but there are too many cars wanting to use our City. We have got to improve the public transport. There is a limit with what you can do on public transport in Bristol, unlike other cities such as London and Manchester,

d) **Transport questions:** AP added that in the papers for the meeting there are responses from Peter Mann to the other questions which we did not have time for at the last Open Forum. Unfortunately Peter Mann got yhe wrong idea on the costings question, which, as a consequence, wasn't answered.

South Glos (CPNN) – No public consultation yet but it is expected that a bus lane will run from Cribbs Causeway through Falcondale Road to Whiteladies Road. They will not improve the roads for everyone, only buses and cyclists.

## **Local Developments & Projects:**

## Roger Gamlin, Co-convenor, Stoke Bishop Residents' Planning Group: -

1 **Dairy Crest site** – Shepperton Homes now making progress and the 14 houses could be finished by the end of the year. A couple have already been sold.

2. **The Hiatt Baker site** – the parking had caused a lot of problems. Students should not be bringing cars but if they do, they must be parked at least 2 miles from the residence. The University are enforcing this. Shaplands asked for an RPZ but would not get it until 2018. They have got double yellow lining and 28 residents of the 32 want further parking restrictions. Fences are being knocked down, hedges trodden on and bottles left around. There is a condition in the planning that there would be parking reviews.

In 2008, the Council sent out a statement of community involvement. They have just sent out a new draft requesting comments by July, catagorised Housing Developments. It is on the Council website: www.bristol.gov.uk/node/1595.

Roger pointed out there is a national coach service to London running 4 times a day from the hub during term time.

There have been real problems with Churchill Hall parking. University seem not to be bothered. David Baynton suggested inviting someone senior from the University to come to the next Open Forum and this was thought a good idea and will be followed up.

**Tree Issues** – Stephanie French produced a report. The Cedar of Lebanon in Stoke Lodge is dead. We are hoping to be able to sculpt the trunk. BCC will remove the canopy but leave as much of the trunk as possible for sculpting, and branches for play. There is a £10K Art grant available, and other sources and as a last resort, residents! Trees now planted from 3 Stoke Hill S106 money. Very good quality trees have been planted in Hiatt Baker.

**Well Being Fund:** Gay reported that no applications had been put in from Stoke Bishop at the last round. We had received another £10K for the year, but £565 had been put towards our share of the Cycling on the Downs event which had taken place in April.

#### **Feedback and Priorities:**

a) Police/PCSO Feedback: PC Jeanette Cadden introduced herself. She is keen to get involved in the community. Our main areas of concern are burglary, antisocial behaviour and parking. A gang of youths had been going round the neighbourhood causing damage, but they have now been identified and all been dealt with. Jeanette is always available when on duty on her mobile: 07889 656832. She hopes to have a PCSO within the next 8 weeks. Cars continue to be broken into for loose change, but someone had been arrested for this and admitted doing over 100! PA wished to express his thanks to the police for the

treatment he had received following his car break-in.

b) Jeanette was asked about the assaults on the Downs but this was being dealt with by the CID. A resident asked about a spate of graffiti still occurring in Hollybush Lane and this was asked to be investigated. The culprit who had been spraying the bus stops was photographed and the police given his details. Jeanette would follow this up. Her Sergeant is Adam Dolling, Tel: 9454626.

#### c) New community actions and priorities:

Westbury-on-Trym Library closure – consultation period has been extended to the end of June. AP asked all to complete the consultation form – copies provided – and return them to the library, or complete it on line. WOT library is used by 4000 people, old and young alike, and would be great loss. Sea Mills library also likely to close. A leaflet would be circulated to all households in the next week or two. The campaign is "Keep it Open". It might eventually result in a new build at a later date. SF pointed out that Redland library was also due to close, and this was the only one that was accessible by public transport.

**Town & Village Green:** DM reported that this had been going on for five years. There were 4 objectors – BCC, Bristol University, Rockleaze Rangers and Cotham Academy. The latest objections were from Cotham and BCC. He was submitting the response by the 16<sup>th</sup> June. It goes back to the Inspector. It then goes to the Public Rights of Way committee for them to make a decision. The latest submission from the objectors is available from the BCC planning department – 10 pages from Cotham and 20 pages from BCC.

**Ward Boundaries:** This was announced today. The new boundary for Stoke Bishop/Sneyd Park is extended to Sylvan Way so the centre of Sea Mills will now be in the Stoke Bishop Ward. JG explained there would be little difference for us, but it was a huge difference for Westbury-on-Trym/Henleaze. That Ward would now be called Westbury-on-Trym and Henleaze Ward and would now have 3 councillors, instead of 4. The NP will change next year in May 2016 following the elections.

## Any other Business:

- 1) SF said Wessex are moving out from the Trymside area which they have been using. She has photographs of what it looked like beforehand, and they have to restore it to its former appearance.
- 2) Gay said the playground on Stoke Lodge was well used, and parents were hoping

to get more equipment suitable for older children or at least some additional swings. A group had been set up by Mr Quilter.

3) Maurice Husbands asked when we were going to get a review of the 20mph scheme. This was promised by the Mayor but he has been unable to get any response. AP said the Mayor loves it and wants to keep it. We could ask him to come of our Open Forum to answer questions, and this was agreed to try to do this with a long advance warning of the date.

**Ward representative elections.** GM confirmed that an election was not necessary due to the number of applicants being less than the places available. VB, MC and HF were confirmed as the representatives. The fourth place for Henleaze was not filled; GM advised that if anyone was interested in filling this place as a co-opted representative they should contact Andrew McGrath

ST had not sought re-election. GM thanked him for his efforts as a ward representative over several years

**Police update.** PC advised that he is the Neighbourhood Officer for Lawrence Weston and that he was standing in at the meeting for his Henleaze colleagues. Since the last Forum, PC Paula Donnelly has been promoted to sergeant and has moved to Trinity Road station. Her temporary replacement is PC Joanne Robertson. In addition PCSO Paula Perry has moved to work in Lawrence Weston with PC; her replacement is Richard Mathias. PCSO Toby Rideout remains as a PCSO for Henleaze.

## Crime figures:

There were nine dwelling burglaries with six premises being accessed through insecure doors. The police continue to promote Immobilise (<a href="www.immobilise.com">www.immobilise.com</a>).

There were two commercial burglaries in the period.

No distraction burglaries took place.

Ten sheds were broken into. Items taken included pushbikes.

There were 66 thefts from motor vehicles with 28 of these being regarded as insecure vehicles.

In addition to the 66 thefts from motor vehicles, there were 23 cases of vehicle interference (e.g. trying to gain access but not taking any items).

No anti-social behaviour crimes.

Dog bites. PC advised of two recent incidents whereby a white West Highland terrier had bitten people. A victim from Canford Park advised that he had seen the dog before. The dog was described as being scruffy looking and having a dark haired owner in his/her mid 20s. The owner carried a red lead.

PC requested that if anyone has any information they should contact the beat team at BristolNPTNorth@avonandsomerset.police.co.uk.

Responses to issues/questions

#### Matters raised were as follows:

Problems for delivery lorries to the Co-Op in Henleaze Road. Concern raised about disabled motorists moving cones in order for them to park on double yellow lines in Cardigan Road.

Parking at the junction of Henleaze Road and Cavendish Road is causing traffic chaos.

Confirmation was sought that parking on the end of zig-zags by a zebra crossing is a police matter. PC confirmed this is correct and that for a second offence it leads to a £60 fine and 3 points.

## Library consultation. Key points arising were:

The Libraries for the Future consultation is going ahead until 30 June 2015 as planned, notwithstanding that the Mayor has advised that no libraries in Bristol will be at risk of closure before April 2016. (www.bristol.gov.uk/page/leisure-and-culture/future-bristols-libraries-consultation)

The consultation is critical to make sure that all potential opportunities are explored for working with local communities and potential partners to adapt the library service to current needs.

Comments from the first stage of the consultation will not be carried forward so it is important to comment during the second stage, whether or not you participated in the consultation earlier in the year. It is important that younger people also complete the survey (it was suggested that notices could be placed in pre-schools, infants and

junior schools).

Out of the seven Bristol libraries that are potentially due to close, four are in or close to our Neighbourhood Partnership (NP) area. The four libraries are Clifton, Redland, Sea Mills, and Westbury-on-Trym.

Whilst Henleaze library (with the highest footfall in Bristol other than the Central library) is due to remain open, the closure of one or more of the four libraries previously referred to, would potentially lead to excess demand in Henleaze.

Library opening hours are being reviewed; potentially Henleaze library might open on Sundays and close on Wednesdays.

Representatives of a group that has been set up to try and keep Westbury-on-Trym library open were present at the meeting. They advised that leaflets would be delivered to all addresses in Westbury-on-Trym and Stoke Bishop within two weeks of the Forum.

**St Ursula's E-ACT Academy**. Since the last Forum, the St Ursula's planning application had been submitted and was discussed at the Bristol City Council Development Control Committee.

Committee members were shocked to hear the percentage of pupils that travelled to the school by car, and also to hear that no Travel Plan had been submitted. It was made clear that the school would have to have a Travel Plan once it has moved into the new build.

It was decided to allow the planning application related to the St Ursula's site to go to the Secretary of State for approval. Currently the school has 390 pupils; it will increase to 630.

Thanks were expressed to Clare Marshall for all of the work she has undertaken to help local residents in connection with the application. The planning application does not include the grade II listed building where the original intention was to turn the building into flats.

## **Transport.** Subjects discussed included:

- Improving crossing/ traffic calming around Henleaze Junior School
- Wellington Hill West zebra crossing
- West Broadway/ South Croft. Local residents have advised that West Broadway is being used for 'rat running'
- Henleaze Road, exit from Tesco Express and Esso
- White Tree roundabout. The survey of the White Tree roundabout bus lane has been completed; we are awaiting the results
- Downs parking. There is a consultation (concluded on 26 May) about possible parking restrictions on The Downs.
- Cribbs/Patchway New Neighbourhood. As previously covered at Forums, the confirmed and proposed development will put a major strain on the main roads

leading into Bristol - including Henleaze Road

 Waitrose. Waitrose propose making the exit/ entrance to the car park more user friendly

#### **Environment.**

- Devonshire Road. Stephanie French (NP tree champion) provided an update on the lack of progress regarding two experimental tree pits due to be installed in order to avoid further damage to the pavement
- Green Capital. There is £10,000 available to each NP for arts projects paid for by Green Capital funds.

**Planning.** The following applications were in progress at the date of the meeting and were highlighted:

- 17 Downs Park West for a first floor extension to enlarge the third bedroom and an extension at first floor level to create more shared living space.

  Concerns have been expressed about the proposed design
- Proposed changes at Esso/Tesco on Henleaze Road for new image forecourt signage. This involves three non illuminated wave signs, three non-illuminated Koala signs and six non-illuminated pump number signs.

#### People.

Young People. ST advised that the ward representatives are open to suggestions about support for younger people in the area. If anyone would like to get involved, please speak with one of the ward representatives.

Older People. VB updated the meeting participants on key activity since the last Forum. It has been as follows:

- On 4 March the Working Group for Older People organised a trip to the Mansion House to have tea with the Lady Mayoress
- On 11 May members of the Working Group for Older People had space at an event sponsored by Blue Bird Care at Westbury-on-Trym Village Hall. The event enabled older people to visit various stakeholders to find out about facilities available to them locally
- A trip to Weston-super-Mare is being arranged for 29 July. An application form can be obtained from Gay Huggins: tel: 0117 968 5813
- Plans are being progressed to print an updated brochure in conjunction with LinkAge on activities in NP3 for those aged over 55
- The next meeting of the Working Group is on 8 June

## **Boundary Review.**

In the final recommendations, there is a new merged ward of Westbury-on-Trym & Henleaze with three councillors representing the new ward. The only change from

•

the existing ward boundary, other than merging Westbury-on-Trym and Henleaze, is that the area around Henleaze Lake has been moved to Southmead ward.

#### Open Forum.

- Closure of NatWest in Henleaze Road. It was agreed that it is important to retain one bank in Henleaze. Currently Lloyds Bank have a policy of not closing a branch if it is the last one in a location. Although it has not been confirmed, there is talk that the former NatWest premises may become a branch of Boston Tea Party.
- GM and Ward Representatives were asked if they attend Neighbourhood Watch meetings. HF advised that the Bristol Chair of Neighbourhood Watch (Wendy Hull) is involved with NP3 and that we are aware of developments through her.
- Stephanie French advised that Stoke Bishop ward will increase in size next year as, following the boundary review, part of Sea Mills has been added to the ward.
- GM confirmed that there are no current plans to introduce a residential parking scheme in Henleaze.

#### 2. Bristol Libraries Consultation

Following the extremely well-attended public consultation meeting at Coombe Dingle on 15<sup>th</sup> April, the library Service has published the notes. The HSBWOT area meeting had by far the largest turnout, with the next highest being Brislington with 55 attendees. Most of the sessions had fewer than 10 people attending. The consultation continues until the end of June. The Library Service wishes to reiterate its wish to receive as many survey responses as possible. At the last count at the beginning of May they had received just over 700 responses. The Library service particularly wishes to know about any ideas you have for supporting the service, either locally or across the city.

A final report will go back to Cabinet in July 2015 with the results of the current consultation and to agree the final proposal.

#### 5. NP publicity leaflet

All NPs are being given the opportunity to design the content for leaflets that will highlight the priorities and successes in their own NP areas. The intention is to provide some general information about NPs as well as specific information about the work of individual NPs and their chosen priorities. Examples will be shown at the NP meeting. The Communications Working Group has already initiated discussions on the leaflet design and content.

Due to the need to print the entire city's NP leaflets at the same time (at the end of July), in order to gain cost savings, the NP is <u>requested</u> to delegate the final design and content of the leaflet to the Communications Working Group, which will meet in the coming weeks.

#### 6. NP Plan updates

A template has been designed to enable regular updates on the progress of priorities in the NP plan. The Neighbourhood Coordinator will provide a working copy of this template for reps at the NP meeting.

In order for this template to work logically, the NP plan needs to be updated to include numbered categories and priorities. This will be done by the date of the NP. A copy of the updated plan will be provided to all NP members. It is hoped that rather than provide copies at every meeting, reps will retain their 'original' copy and bring it to subsequent NP meetings and Working Group meetings.

This will enable the Neighbourhood Coordinator to provide updates (on the new template) only on priorities that have been progressed, rather than reproduce the whole plan each NP. This should significantly reduce the paperwork.
