Statement from Helen Pillinger to Place Scrutiny Commission 5th December 2014

Dear Councillors,

I apologise for not being able to attend in person, I hope you find the following helpful and look forward to the outcome. Thanks in advance, from Helen Pillinger

I welcome the Mayor's comment in the November 2014 State of the City address where he acknowledges health risks from air pollution kill more people than road traffic accidents. Also notable our Environmental Quality officer is committed to helping residents and officers understand a technically challenging subject in the quest to reduce air pollution. Air pollution monitoring is still not is as widespread as I and many others believe it ought to be especially in view of Bristol: European Green Capital 2015 .

In this context it may be helpful to draw your attention to the behaviour of the council at the post planning stages of development as it relates to air pollution control.

The city planning/enforcement and transport departments appear to be failing to proactively implement adequate Travel Plan monitoring following development.

While aware liaison exists between Environmental Quality and Planning Department, at pre planning stages usually resulting in Travel Plans which include mitigation strategy, there appears to be reluctance, even failure, to enforce Travel Plan mitigation which could help control traffic volumes, and air pollution from motorised vehicles, despite penalties being due where non compliance occurs.

Failure to set up adequate enforcement protocol post-planning means that where conditions in the Travel Plan are breached, the city will fail to acquire an evidence base to

- a) prove a breach occurred
- b) successfully claim the penalty required from the developer

I raised an example of this at Neighbourhood Partnership (Horfield and Lockleaze) in September 2013, which officers elevated to Enforcement Case 13/30687/BCN. The Travel Plan condition 9 was not enforced despite Bristol City Council commissioning the original development on Land at Dorian Road (approved in April 2008, case ref 07/01523/F) stating non compliance penalty £30,000, believed to be unclaimed.

The impacts are magnified where a cluster of "super major" developments, which increase air pollution such as Southmead Hospital, Land at Dorian Rd and Memorial Stadium as identified in pages 81, 83 of 2008 Local Air Quality Management, Air Quality Progress in Bristol Report.

This is of great concern, not only exposes the city to loss of compensation, but exposes residents to further public health risks associated with medical effects of air pollution.

Neither Neighbourhood partnership officers nor residents can get any reasons why the website shows the Enforcement case as closed without action, or communication.

I now ask you to kindly investigate what appears to be a systemic failure for further investigation either via Place, Audit or Resource Scrutiny process.
