- 4.3 In future, the awarding of funding will be aligned with the Neighbourhood Partnership Plan and the Panel recommend that the Plan contains the Neighbourhood Partnership priorities and that projects are actively sought to deliver these priorities.
- 4.4The Panel felt that their recommendations were overruled by the Neighbourhood Committee at the last Neighbourhood Partnership meeting and would like the Neighbourhood Committee to ensure they take the Panel's recommendations more seriously. Councillors are asked that if they are unable to attend the Grants Panel that they give some feedback prior to the meeting, if they have particularly strong views on certain applications.

5. The Neighbourhood Committee is asked to make final decisions on the above current applications

6. Legal Information

When councillors decide how the wellbeing fund is spent they should have due regard to the public sector equality duty that applies to all public bodies. This duty is contained in the Equality Act 2010 and came in to force on 6 April 2011. It replaces previous equality duties under the Sex Discrimination, Race Relations and Disability Discrimination Acts. The duty means that councillors are required to have due regard to the need to:

- Eliminate unlawful discrimination, harassment and victimisation and other conduct prohibited under the Act
- Promote equality of opportunity between different groups
- Foster good relations between people from different groups

The duty covers the following protected characteristics:

- Disability
- Sexual orientation
- Age

- Gender reassignment
- Religion and belief
- Sex
- Race
- Pregnancy and maternity

It also applies to marriage and civil partnership, but only in respect of the requirement to eliminate discrimination and harassment.
