#### 1.0 Environment Group

- 1.1 This group met on 11th January 2016.
- 1.2 The group looked at suggestions for Environmental projects across Horfield and Lockleaze and they recommend that the Neighbourhood Partnership allocate £1,320 for annual meadows and £1,080 for 6 hanging baskets from the Neighbourhood budget, Total cost £2,400. The Group will endeavour to seek sponsorship for these items. Further consultation will be carried out to update the Neighbourhood Partnership Plan and to make requests for any further funding in June
- 1.3 Request that Maskelyne Avenue ASB are added to the NP Plan
- 1.6 Total Parks s106 available is £208,358.48

#### 2.0 Traffic & Transport Group

- 2.1 This Group met on the 28<sup>th</sup> January 2016.
- 2.2 Romney Avenue Parking Scheme the preliminary scheme design includes parking restrictions (mostly junction protection), and the installation of tactile paving on drop kerbs. The Group approved the parking restrictions and recommend that the Neighbourhood Partnership allocate £4000 for this part of the scheme. The Group would like to include a pedestrian crossing in this scheme; the Highways Engineer agreed to do this and estimated that this may cost £25,000. The Group anticipate that this will be part funded by the Neighbourhood Budget and part by s106. The Group will look at the full proposal which includes the crossing and tactile paving at the April meeting and bring back any requests for funding to the June Neighbourhood Partnership.
- 2.3 Church Road this will be dealt with by Bishopston, Cotham and Redland Neighbourhood Partnership following the boundary changes in March 2016.

- 2.4 Minor Works As in previous years the Group recommend that the Neighbourhood Partnership allocate £5000 for these schemes in 2016-17.
- 2.5 Bus workshop the Group carried out a workshop to look at issues with buses, this was a pilot for the forms that will be used at the Forum.
- 2.6 Dorian Road bus stop this will be moved back towards the TA centre to prevent buses blocking the road

- 2.7 Dorian Road Congestion this continues to be an issue which is difficult to resolve. The Traffic and Transport Group will be working with Councillors and officers from Bristol City Council and the Hospital to try to improve this junction.
- 2.8 Total Transport s106 available is £190,537.71

#### 3.0 Employment and Economy

- 3.1 This group met on the 19<sup>th</sup> January 2016.
- 3.2 Job Opportunities at Lidl The development is still on hold while highways issues are resolved
- 3.3 Paul Owens described his role as regeneration project manager for Lockleaze. He is currently scoping out his work focusing on 6-7 key sites initially:
  - a. Herkomer Close & Thorneycroft Close
  - b. Branwhite Close Police Station & Cameron Centre sites
  - c. Blake & Day Centre sites
  - d. Bonnington Walk former allotments
  - e. Crome Rd PRC site
  - f. Lockleaze secondary school & Romney House

He is aiming to finalise a delivery strategy by summer, including an assessment of the capacity of the sites and market analysis of housing needs and commercial viability. The developments need to be affordable and deliverable, bearing in mind that good quality housing is not cheap to build.

#### 4.0 Grants Networking Event

- 4.1 The Grants Networking event was held on the 3<sup>rd</sup> February 2016. 36 people attended and enjoyed a programme of 10 talks by groups who had benefitted from Wellbeing and Green Capital funding over the past 2 years. Of these attendees 7 were residents that were new to the Neighbourhood Partnership. The evening was a great success with new connections being made and information shared between groups.
- 4.2 The meeting was asked how much funding should be allocated for Wellbeing projects. There was not much discussion about this but those that did input felt that £20,000 was about the right amount. The Grant Panel therefore request that £20,000 allocated to Wellbeing Grants in 2016-17. The Neighbourhood Partnership Committee is asked to approve this change in funding.
- 4.3 The meeting was asked to look at the Wellbeing priorities. There was not much discussion about the priorities, but it was suggested agreed that the following priorities should stay:
  - Community facilities

- Employment & Economy
- Provision for young people
- Equalities and community Cohesion
- Improving the health of residents
- Domestic abuse
- Traffic, transport & pollution

The existing priority of Communication and engagement was not included on this list

The follow priorites were suggested in addition

- Re-use and recycling
- Arts and culture
- · Support for carers

These proposals will be discussed with the Grants Panel who will make recommendations to this meeting.

The Neighbourhood Partnership is asked to discuss and agree these proposals.

## 5.0 Neighbourhood Budget

- 5.1 The total devolved provisional Neighbourhood Budget for 2015/16 is £46,441.00 (this budget will be confirmed once the Highways carry-over figures are received). This is in addition to CIL and Section 106 funds.
- 5.2 The table shown below shows the 2015/16 Neighbourhood Budget, updated with the proposals for funding to date.
