Following the announcement of an additional award of 0.30% by the arbitration panel appointed to settle the 2008 pay dispute, the revised payscales and allowances attached at **Annex 1** (in bold type) should now be implemented **with effect from 1 April 2008**.

Please note that the new figures reflect an increase of 2.75% (plus £100 per annum on spinal column points 4, 5 & 6) on the April 2007 payscales, and not an increase of 0.30% on the April 2008 payscales (as published in NJC Circular 2/08 dated 17 October 2008).
