Summary

The report sets out for members, information on the implementation of the Council's policy for caretakers in tied accommodation which was approved at HR Committee in 2007.

At its meeting on 2nd April 2009 the HR Committee, as a matter arising, passed the following resolution:

"That a report outlining non-implementation of the Tied Accommodation Policy by Head Teachers/Governing Bodies be brought to a future meeting (July) of the Human Resources Committee".

1. Policy

- 1.1 Previously HR committee determined that with effect from 1 November 2007 caretakers in tied accommodation would:
 - be charged a standard rent
 - receive a reduction of 75% in their council tax (for single caretakers this is in addition to the 25% reduction, making 100% reduction)
 - be responsible for paying their own water rates

3. Context

- 3.1 Currently 63 schools in the city have resident caretakers. Of these schools:
 - 4 caretakers are in Voluntary Controlled (VC) Schools
 - 5 caretakers are in Voluntary Aided (VA) Schools
 - 7 schools' caretakers have transferred to a PFI
 - The remainder (47) are in community schools.
- 3.2 In Community and VC schools the City Council is the employer. In VA schools the governing body is the employer and as such the Council cannot implement this policy in these schools, it is for the governing bodies to determine the schools' policies. However the Council can recommend this policy to VA schools for adoption. Caretakers who have transferred to another employer under TUPE (PFI/BSF schools) will have transferred to the new employer on the same terms and conditions as were in place at the time that they transferred.

- 3.3 Two VA schools have adopted this policy and the Council has recently written to the governing bodies of the remaining VA schools recommending that they adopt this policy. (see attached letter, Appendix A).
- 3.4 All community and VC schools are following the HR Committee decision on this policy.

Letter to Chair of Governors of VA Schools With Resident Caretakers

Dear (name of Chair of Governors)

Caretakers' Tied Accommodation

In 2007 the Council's HR Committee considered caretakers' tied accommodation charges across the Council and determined that:

- a standard rent should be charged to all caretakers (currently £63.78)
- the Council tax caretakers pay to reduce by 75% (for single caretakers this is in addition to the 25% reduction, making 100% reduction)
- caretakers will be responsible for paying their own water rates

This now applies to all the caretakers who work in Bristol City Council Schools.

As you are aware the governing body of an aided school is the employer, and as such is legally responsible for determining the employment decisions and the school's pay policy. Not all voluntary aided schools have adopted the above policy in relation to the council tax subsidy and the payment of water rates. I am therefore writing to ask you to consider adopting the above policy for caretakers' tied accommodation. This will bring your school's caretaker's payments into line with the City Council's caretakers.
