- Gynaecological cancer review three OSCs (Bristol, B&NES and North Somerset) have found the proposals to be a substantial variation. Joint committee has been established with first formal meeting to be held in June 2010 at B&NES (date to be confirmed).
- Specialised services commissioning Stage 1 proposals on soft tissue sarcoma went to all OSCs October 2009. Stage 2 proposal also to go to OSCs, date tbc.
- Head and Neck Cancer impact assessments expected to come to OSCs in July 2010.
- September 2010 Orchard View final report (to include update on all outstanding as discussed at JHSC meeting 25/1/10)
- Specialised services commissioning neonatology provisionally due to come to OSCs approx. autumn 2010
- Paediatric cardiology review is being led by National Specialised Commissioning Group. Further information expected shortly from CfPS as to how OSCs will be involved.
