# JHSC 33.4/10 BHSP UPDATE REPORT

The Committee considered a report of David Tappin, NHS Bristol (agenda item no. 6) noting and commenting on the information.

David Tappin introduced the report and summarised it for Members.

During the debate and questioning that followed the following points were made:

- It was noted that the site for Clevedon Hospital had been acquired; NHS North Somerset would provide further information on how the building was to be financed - it could be done in one of a number of ways - PFI, LIFT or NHS Capital Funding
- The construction period for Eastville Community Health Care Centre would be fairly short; the strategy for what services would be provided there bearing in mind its relative proximity to Cossham Hospital was being worked on with NHS South Gloucestershire
- A stakeholder event is being organised for June 2010 to allow stakeholders to consider the draft options for Frenchay Hospital which is planned to be a community

hospital which also include extra care and rehabilitation services; Local Authority Scrutiny Members would be invited to the event

- It was acknowledged that North Somerset Council needs to be kept informed as acute services move out of Frenchay Hospital into the new Southmead Hospital
- As the Healthy Futures Programme is only being developed there is no information about it on the website
- The community care component of the out of hospital care pathway is critical
- The service design programme has to ensure that appropriate infrastructure is in place bearing in mind local needs which need to be reflected in the development and implementation of services

David Powell gave a presentation on the plans for the new Southmead Hospital

### JHSC 34.4/10

#### BHSP SERVICE DESIGN PROGRAMME UPDATE

The committee considered a report of David Tappin/Helen England, NHS Bristol (agenda item no. 7) noting and commenting on the information.

Jo Underwood introduced the report and summarised it for Members.

During the debate and questioning that followed the following points were made:

- The objectives listed on page 23 were set out at the start of the process, but it is an ever changing situation
- The main emphasis is always on improving the patient experience rather than being focussed only on National

Targets and all services are designed with this in mind

- Waiting times have been considerably reduced recently
- There will be a reduction in the percentage of money spent on acute care in comparison to community care during 2010/11
- Re-admission rates for NBT and UHBT are relatively low in comparison to the rest of the country
- There will more elective procedure performed away from acute hospitals and there will be a reduction in the number required as a result of preventative measure
- There will also be fewer out patients at the new Southmead Hospital there are currently at Frenchay and Southmead Hospitals
- Individual Trusts have procedures for dealing with out patient appointments not attended

- Cardiac rehabilitation is being trialled by NHS Bristol on behalf of the two other PCTs
- The option of offering home births to expectant mothers also helps attract midwives to the profession

- The aspect of sexual health identified in the report is one of many aspects of the sexual health work programme
- One individual is identified to ensure that everyone else is aware of a patient's wishes who has entered the end of life phase
