Summary

This report provides details of the suggested approach for finalising the Overview and Scrutiny Work Programme for 2014/15

The significant issues in the report are:

The need to ensure a robust work programme for 14/15

Policy

1. Under the Local Government Act 2000, Bristol City Council is required to establish an Overview and Scrutiny function. The Overview and Scrutiny Management Board is the parent committee for the scrutiny function and is the vehicle for coordinating the overall scrutiny work programme on behalf of

the Council.

2. Constitutional amendments agreed by Full Council on 10th June 14 have resulted in a change in the way that Scrutiny work programmes are devised, with the Overview and Scrutiny Management Board (OSMB) now agreeing a single Overview and Scrutiny work programme at the start of the Municipal Year, based on the City Council's forward plan of policy development and decision making. This report does not seek to address the work programmes for joint Scrutiny, which will be prepared in conjunction with relevant partners.

3. The Scrutiny Committees for 14/15 have been remodelled so they are aligned to Bristol City Council's directorates to create a simpler and more consistent interface. There are now four Committees; Business Change, Neighbourhoods, People and Place.

Consultation

Internal

4. A Scrutiny workshop took place on 19th June 2014 where Members prepared draft work programmes for each Committee, informed by strategic priorities, policy development and the Council's decision making framework. At the workshop, a number of additional topics were added and proposed dates for scrutiny activities were amended.

External

Context

OSMB Work Programme

- 6. It has been agreed that OSMB will manage a single work programme, allocating tasks to other Committees and closely monitoring performance.
- 7. The draft OSMB work programme for 14/15 can be found at appendix 1.

Scrutiny Workshop and Draft Work Programme

8. A broad range of Members met on 19th June 14 to prepare the draft

Scrutiny work programme for 14/15. The approach differed this year because a three-year Medium Term Financial Strategy had been set in February 14. This will enable better planning of scrutiny activities, particularly policy development.

- 9. The workshop was a productive experience and Members helped to prepare a detailed programme of potential topics, which are listed at Appendix 2. Officers are in the process of reviewing the proposals in order to ensure the work programme is timely and utilises resources in the most effective way.
- 10. One of the areas that needs to be fully explored is the use of different types of Scrutiny. At the workshop, Members identified 10 inquiry day topics, which is a reflection of their popularity and success in recent years, but that is more than the City Council is able to support. In order to ensure inquiry days continue to be highly valued, the topics should be carefully selected and they should be limited in number. OSMB will wish to consider whether Select Committees; working groups; site visits; questionnaires; joint work with the Neighbourhood Partnerships and so on could be utilised in some areas.
- 11. It is essential to ensure that OSMB retains enough flexibility in the work programme to respond to urgent issues that could arise throughout the year, including as Call Ins. The draft work programme prepared at the work shop will be rationalised to make better use of themed meetings which will free up more time.
- 12. OSMB are asked to consider the topics identified at the work shop on 19th June which are listed at Appendix 2 and provide officers with instructions regarding any areas that should be prioritised. OSMB are also asked to agree that officers be permitted to prepare a revised work programme for circulation prior to the Committee AGMs in late July 14.
- 13. OSMB will retain control of the scrutiny work programmes to ensure they align with the City Council's strategic priorities and policies. OSMB will review the work plan regularly and will receive progress reports from each Committee.

Meeting Dates

14. All Scrutiny Committee meetings will take place on Mondays, Thursdays or Fridays. This will ensure maximum support from senior officers, Assistant Mayors and the Mayor, who would find it difficult to attend at other times as all corporate business now takes place on Tuesdays and Wednesdays.

Co-optees and Expert Witnesses

15. OSMB has previously asked Committees to consider the use of expert

witnesses in place of non-statutory co-optees where appropriate due to the increased breadth of knowledge and experience that can be brought to the table. Whilst Co-optees can add real value, in some cases attendance and participation at meetings has been an issue. OSMB should consider the use of co-optees and expert witnesses and provide advice to the Committees as appropriate.

Licensing Policy Scrutiny Board

17. The Licensing Policy Scrutiny Board was set up by OSMB as a vehicle to develop Bristol City Council's statutory Licensing policy prior to approval by Full Council. This work will now be passed to the Neighbourhoods Scrutiny Committee. In 14/15 there will be a report on the outcomes of the recent consultation on the revised Licensing policy, but in future years there may be a requirement for the Committee to conduct more intensive policy development work. OSMB should note this approach for 14/15.

Other Options Considered

Risk Assessment

19. Overview and Scrutiny is a key vehicle for delivering local accountability. It is therefore essential to ensure there are effective overview and scrutiny arrangements in Bristol which can contribute positively to good governance and potentially increase public confidence and involvement in the democratic process.

Public Sector Equality Duties

Equalities Impact Assessment

20a. Before making a decision, section 149 Equality Act 2010 requires that each decision-maker considers the need to promote equality for persons with the following "protected characteristics": age, disability, gender reassignment, pregnancy and maternity, race, religion or belief, sex, sexual orientation. Each decision-maker must, therefore, have due regard to the need to:

- i) Eliminate discrimination, harassment, victimisation and any other conduct prohibited under the Equality Act 2010.
- ii) Advance equality of opportunity between persons who share a relevant protected characteristic and those who do not share it. This involves having due regard, in particular, to the need to --
 - remove or minimise disadvantage suffered by persons who share

a relevant protected characteristic;

- take steps to meet the needs of persons who share a relevant protected characteristic that are different from the needs of people who do not share it (in relation to disabled people, this includes, in particular, steps to take account of disabled persons' disabilities);
- encourage persons who share a protected characteristic to participate in public life or in any other activity in which participation by such persons is disproportionately low.
- iii) Foster good relations between persons who share a relevant protected characteristic and those who do not share it. This involves having due regard, in particular, to the need to
 - tackle prejudice; and
 - promote understanding.
- 21b) The scrutiny function has a key role to play in assisting the Council in meeting its public sector equality duties and to ensure that the views of different communities and members of the public are taken into account in the development and delivery of services. Task and Finish Groups such as Inquiry Days, Select Committees and Working Groups need to ensure assessment of equalities impact forms an integral part of their work both in terms of scoping topics, gathering evidence and formulating recommendations.
