DIVERSION ORDER PROW NO: 140, DOVERCOURT ROAD, LOCKLEAZE

- (ii) if no objections to the order are received, that approval be given to confirmation of that order as an unopposed order.

RIGHTS OF WAY IMPROVEMENT PLAN
