# DIVERSION OF PUBLIC RIGHT OF WAY NO 226 AT DUNDRY HILL FARM, WHITCHURCH PARK

The Committee considered a joint report (Agenda Item No. 5) of the Director of Planning, Transport and Sustainable Development and Director of Central Support Services (Head of Legal Services) to determine an application seeking a Public Path Diversion Order to divert part of Public Footpath 226 in Bristol.

The representative of the Director of Planning, Transport and Sustainable Development introduced the report and informed the Committee that;

(i) Public Footpath 226 had been well used until 2006, when it had become apparent that an Order processed in 1972/3 contained insufficient wording. This had enabled the landowner to prevent access to parts A to B of the route (as

- shown on Appendix (5) A) by removing a style.
- (ii) Local residents were strongly in favour of reinstating access to the route, and after negotiations involving the land owner and both local ward members it had been agreed that the path could be diverted around the edge of his field.
- (iii) It had been agreed that the original proposal for Public Footpath 226 to exit at point D1 (as shown on Appendix (5) A) would be amended to point E (located within Bath and North East Somerset, and also shown on Appendix (5) A) to avoid the path terminating on a blind bend.
- (iv) Should the Order be approved, the diversion to Public Footpath 226 would be arranged with both of the relevant local authorities at the same time.

On being put to the vote it was unanimously -

### **RESOLVED -**

- (i) that the Head of Legal Services be authorised to make and advertise a Public Path Diversion Order in respect of Public Footpath 226, to divert the path so that it follows the new alignment marked C-D-E (as indicated on Appendix (5) A); and
- (ii) that, if no objections are received to the Order, approval be given to confirm it as an unopposed order; and
- (ii) that the Head of Legal Services be authorised to enter into an agreement with Bath and North East Somerset Council, under section 101 of the Local Government Act 1972 and all other enabling powers, to exercise the function which that authority has under section 119 of the Highway

# CLAIMED FOOTPATH FROM BERKELEY ROAD TO FP567 (FRIARY ROAD)

The Committee considered a joint report (Agenda Item No. 6) of the Director of Planning, Transport & Sustainable Development and the Director of Central Support Services (Head of Legal Services) advising members of the responses that had been received to the Notice of Making of a Modification Order relating to the aforementioned path, in order to establish the stance the City Council would take when referring the Order to the Secretary of State.

Members considered the request submitted from Carmen Grima, on behalf of Mrs Christine Blackwell (Public Forum Statement No.2), to defer consideration of the item, but having received advice from the representative of the Head of Legal Services, resolved that there were no grounds to do so.

The representative of the Head of Legal Services introduced the report and advised the Committee that, as the objections received were similar to those previously submitted, there were no grounds to disregard the Officers' recommendation, which was to refer the Order to the Secretary of state with a request that it be confirmed.

Whilst considering the matter, Members requested that a clearer copy of Appendix B to the supplementary information report be provided, so an original, colour copy of the document was circulated. The Chairman also asked Officers to ensure that in future all maps and diagrams be as easy to read as possible.

On being put to the vote it was unanimously -

#### **RESOLVED -**

- (i) that approval be given to accept the objections received as duly make objections under the Wildlife and Countryside Act 1981; and
- (ii) that the Order be referred to the Secretary of State with a request that it be confirmed.
