APPLICATION FOR THE GRANT OF A PRIVATE HIRE DRIVER LICENCE – AB

(Exempt paragraph 3 – Information relating to person's financial or business affairs)

The Sub-Committee considered an exempt report of the Director of Neighbourhoods (Agenda Item No. 6) considering an application for the grant of a Private Hire Driver (PHD) licence.

AB was in attendance, accompanied by GH.

The Chair explained the procedure that would be followed and everyone introduced themselves.

The Licensing Officer introduced the report and summarised it for everyone.

GH presented the case for AB and answered questions highlighting the following:

- Another one of the company's drivers received a similar exemption 18 months ago; this resulted from the company being asked to provide a female driver by some customers
- AB has worked for the Royal Family and has completed Police and Anti Terrorist Training; he was recommended to the company when it took on more work
- AB will not work in Bristol and will only work for Home James, he will not be taking cash and most journeys will be long distance; he will be taking the NVQ Gold Standard
- The company applies due diligence and all journeys are carefully researched and planned; they do not rely solely on sat. nav.

- AB has held a North Somerset Council Private Hire Licence for 14 years
- If AB leaves Home James any licence granted would be surrendered; (it was noted that this is not enforceable)
- 3 of the points on the DVLA Licence held by AB are due to be removed soon
- The company seeks to work with Bristol City Council
- He summed up the case

AB stated that he has held a North Somerset Driver's and Operator's Licence and has now joined Home James.

All parties and the representatives of the Director of Neighbourhoods left the room.

CONDITIONAL CAUTION OF A HOLDER OF A HACKNEY CARRIAGE DRIVER LICENCE AND PRIVATE HIRE DRIVER LICENCE – DP

(Exempt paragraph 3 – Information relating to person's financial or business affairs)

The Sub-Committee considered an exempt report of the Director of Neighbourhoods (Agenda Item No. 7) determining if any action is required as a result of a Conditional Caution being received by a licensed Hackney Carriage Driver (HCD) and Private Hire Driver (PHD).

DP was in attendance accompanied by his wife.

The Chair explained the procedure that would be followed and everyone introduced themselves.

The Licensing Officer introduced the report and summarised it for everyone.

Members noted the statements received in support of DP.

DP presented his case and answered questions highlighting the following:

- He had just dropped off a previous passenger and was flagged down by a woman on Fishponds Road; the woman got into the car, asked him to drive around the corner and stop; there she offered him sex and a blow job; he refused the offer; she then asked to be taken to another destination, paid her fare and got out of the car
- About a mile from the drop off point he was stopped by Police in an unmarked car; he was put in the Police car and accused of kerb crawling in relation to a known prostitute; he was not aware that she was a prostitute; he was told it was an offence to have picked up the woman and was threatened with prosecution and being named in the newspapers; he was frightened and intimidated by this and accepted the Caution
- He consulted a solicitor who gave him bad advice in advising him to accept the Caution; he now wished that he would have gone to court as he did not do anything wrong; he has never been in any kind of trouble before; his wife confirmed that she supported his decision to take the Caution, but neither of them realised the consequences of this decision
- He reported the Caution to the Licensing Office the following day
- He attended the Change Course and felt he learnt a lot from it; however he was wrongly advised by the Course Instructor that no taxi driver had ever lost their licence as a result of a Caution

- It was not an unusual request to be asked to stop by a customer a very short distance from the pick up point
- He will do his best to never being put in the same situation again by being much more careful
- He summed up his case by reading out a statement and asking that no action be taken on his licences

It was noted that a Hackney Carriage driver cannot refuse to pick up a passenger without good cause.

All parties and the representatives of the Director of Neighbourhoods left the room.

Details of the Committee's findings and reasons for the decision are set out in Appendix 2.

Members noted the statements of support for SAK including those from Councillors Choudhury and Khan, and Jenny Smith, as well as the other letters tabled.

SAK presented his case and answered questions highlighting the following:

- He is very sorry for committing the offences and he pleaded guilty
- He explained the circumstances of the offences and the difficulties he would be presented with if he lost his licence
- He is aware that what he did is illegal and acknowledged that he should have been more careful and not picked up the passengers; this the first time he has ever done this and will never do it again

Councillor Khan made a statement on behalf of SAK.

SAK's colleague also made a statement on behalf of SAK.

SAK summed up his case and asked that he be dealt with sympathetically

All parties and the representatives of the Director of Neighbourhoods left the room.

Reasons for Decision

Members considered very carefully all of the written and verbal evidence presented to them.

Members noted that AB has worked for the Royal Family implying a high level of competence and knowledge, and that he has received high level security clearance as well as Police and Anti Terrorist Training. They also noted that this work (for the Royal Family) is not conventional private hire work. Finally they noted the offer of the return of the licence should he leave Home James, (even though this is not enforceable).

They therefore agreed to make an exception to their Policy and grant AB an exemption from being required to take the Knowledge Test.
