RECOMMENDATION

That the committee

- (i) note the functions falling within its terms of reference that are discharged by officers in the Private Housing team; and
- (ii) agree that, in addition to the Director being able to exercise the functions himself, they may be exercised by those officers occupying the posts identified by him in appendix 1 in the manner there described and accordingly the Director's arrangements are given effect directly and particularly by this committee.

Summary

The report informs the committee of how matters falling within its Terms of Reference are included in the work of officers in the people Directorate and seeks the committee's approval of the arrangements for discharge of functions

The significant issues in the report are:

Post holders in the People Directorate are authorised to exercise nonexecutive powers delegated by this committee. This does not alter existing delegations to officers in other Directorates.

Policy

1. The Council's constitution anticipates most council business being undertaken by officers acting in line with arrangements made by their Director, with more significant decisions being taken at a meeting of the relevant body. This report is wholly consistent with that approach.

Context

- a) The Private Housing Service is now part of the People Directorate. The service helps to protect tenants in the private rented sector and in some circumstances to assist home owners affected by nuisance or annoyance caused by neighbouring properties. The service also regulates a small number of residential mobile home sites under Caravan site and Mobile Homes legislation.
- b) Full Council has delegated to the Public Safety and Protection Committee all functions relating to public safety and protection as specified in Regulation 2 and Schedule 1 to the Local Authorities (Functions and Responsibilities)(England) Regulations 2000 (as amended) under the following provisions and any related secondary legislation and has done the same for the "local choice" functions. Much of the work undertaken in relation to the matters falling within the committee's terms of reference is undertaken by officers in the Neighbourhoods Directorate. This report is only concerned with the work undertaken in the People Directorate.
- c) This report asks the committee to note and approve the arrangements made for discharge of certain non- executive functions by officers occupying particular posts.
- d) In summary the non-executive functions concerned are:
 - *i.* Abating or preventing statutory nuisance Environmental Protection Act 1990.
 - *ii.* Licensing of Caravan Sites Caravan Sites and Control of Development Act 1960, the Caravan Sites Act 1968 and the Mobile Homes Act 2013.

iii. Community Protection Notices and associated powers - Antisocial Behaviour, Crime and Policing Act 2014 (but only insofar as they are relevant to the functions in the committee's terms of reference – for example graffiti)

Public Sector Equality Duties
